MINUTES OF SPECIAL MEETING OF COUNCIL, HELD IN THE CITY HALL, ON THURSDAY THE 5TH DAY OF SEPTEMBER, 1907 AT 8:30 O'CLOCK P.M.

The Mayor presiding and all the Aldermen present.

A Report was read from the Clerk relative to the letter received from Messrs Baxter McLellan & Savage, where on the motion of Alderman Jordan, seconded by Alderman Irwin, the Council decided that the necessary deeds and information be furnished to Messrs Baxter McLellan & Savage to enable them to investigate the Title of the Water Frontage Lots for which application had been made for a Grant to the Minister of Marine & Fisheries in December 1905.

Alderman Dick moved, seconded by Alderman Irwin, that the former resolution passed by the Council accepting the Plan of the proposed Sub-division of Lot 1, Block 2, D.L. 5 and 7, be rescinded, and this was agreed to.

Alderman Dick further moved that the altered surveyed Plan Alderman Smith now presented to the Council, showing the Sub-division of said Lot, be accepted. The motion was seconded by Alderman Irwin and unanimously passed.

On the call of the Mayor for any questions before reconsideration of The Local Improvement General Bylaw, Alderman Crickmay moved that the clearing of all unopened Streets be done by the Council to a width of 20 feet, and paid out of the General Fund. Alderman Smith seconded.

On the question being put to the Meeting, there voted:

The previous question therefore became the finding of the Meeting.

The Bylaw was thereafter read and reconsidered by the Council, after which Alderman Jordan moved that Bylaw No. 4, The Local Improvement General Bylaw, be adopted Alderman Smith read. The motion was seconded by Alderman Dick and unanimously agreed to. The Mayor and Clerk were authorized to sign the Bylaw and the Clerk to affix the Corporate Seal thereto.

On the motion of Aldermen Jordan and Emery, a very cordial note of thanks was awarded the Board of Works Committee for the trouble and effort put forth by them in connection with the framing and passage of the Bylaw.

The Committee was asked to forward recommendations with regard to matters pertaining to the satisfactory working of the Bylaw and to submit, for the approval of the Council, any forms required in connection therewith.

The Council ordered that Bylaw be printed, and on the motion of Alderment Emery and Jordan, the matter of making arrangements therefore was left in the hands of the Board of Works Committee.

The Septic Tank Bylaw was read and reconsidered.

Clause 5 hereof was altered to read Alderman Smith follows:

"Any party or parties wishing to install a Septic Tank shall make application to the City Engineer's Office for a permit to install the same, and the Engineer shall furnish the party or parties with the necessary Plans and Specifications."

Thereafter on the motion of Alderman Jordan, seconded by Alderman Irwin, the Septic Tank Bylaw Alderman Smith read was adopted, and the Mayor and Clerk authorized to sign the same and the Clerk to affix the Corporate Seal thereto.

The City Pound Bylaw on being read for a third time was passed by the Council.

A letter from J.J. Burton asking for water connections on Lot B, Block 39, Subdivision 548 was left over for consideration at next meeting.

On the motion of Alderman Crickmay, seconded by Alderman Emery, the Board of Works Committee was empowered to act under the Local Improvement Bylaw in opening up a Wagon Trail on Second Street east from St. Andrew's Avenue to lot on which D. Bourdon is building a residence.
