MINUTES OF REGULAR MEETING OF COUNCIL HELD WITHIN THE CITY HALL, ON MONDAY THE 7th DAY OF OCTOBER, 1907 AT 8:30 O'CLOCK P.M.

The Mayor presiding and all the Aldermen present.

The Minutes of the Regular Meeting of 16th and of the Special Meetings of 26th and 30th September, and 3rd October last were adopted.

Letter from Sister Mary Amy, Principal, Indian Board School, claiming exemption from Taxes in respect of Mission School and grounds.

On motion of Aldermen Dick and Irwin, Council resolved that School and grounds be exempt from taxation for the current year.

Letter from Mrs. Eves, applying for permission to remove house, at present on rear of Lot 12, Block 165 to Lot 20, Block 140. Referred to Board of Works on motion of Aldermen Jordan and Dick.

Tracings were submitted from Mr. Lawson of proposed Sub-divisions of Lots 1, 2 and 3, Block 64, D.L. 271 and Block 50, D.L. 549. Alderman Irwin moved that the same be approved of by the Council. The motion was seconded be Alderman Dick and unanimously agreed to.

Correspondence was read from City Solicitors to Alderman Dick with reference to proposed Sub-division Plan of Lot 7, Block 19, D.L. 548. City Engineer instructed to report on plan to next meeting.

A recommendation by the Police Committee that a Temporary Pound site be located at the West end of 3rd Street was approved of by the Council and a further remit made to the Committee to report on securing a permanent site for the Pound.

On the motion of Aldermen Crickmay and Jordan, Emery, the Council resolved that meetings on the last Thursday of each month be set apart for Committee work.

Letter from W.B. Bunbury, Local Manager, stating that he had received instructions from the General Manager of the B.C. Electric Railway Co. to agree to Council's proposal of Company paying one half of the expense of expropriating sufficient ground at corner of St. David's and 1st Street to permit of proper curve on Street railway being made.

On motion of Aldermen Dick and Crickmay, the Council authorized the Board of Works Committee to take steps to expropriate Lot 17, in Block 152, but in the first instance to ascertain the Owner's selling price of said Lot.

Alderman Smith introduced and ready Bylaw No. 12, "A Bylaw to regulate the manner and conditions on which Liquor Licences may be granted or renewed in the City".

Alderman Dick moved that the Clerk, in his own time, furnish the Ferry Co. with copy of Bylaw authorizing subletting of Ferry Licence and Bylaw confirming Ferry Agreement and charge the Company a fee for his trouble. The motion was seconded by Alderman Irwin and agreed to.
