

**MINUTES OF SPECIAL MEETING OF CITY COUNCIL, HELD WITHIN THE
COUNCIL CHAMBER ON FRIDAY THE 2nd DAY OF DECEMBER 1910 AT
8 O'CLOCK, P.M.**

His Worship Mayor May presiding, and all the Aldermen present excepting Alderman Irwin.

After hearing a verbal report from City Engineer on the advisability of proceeding with the construction of sewers, Alderman Schultz moved that the City Engineer prepare specifications and call separate tenders for the laying of vitrified clay sewers with connections to the property line of each lot on the Esplanade, first, 2nd and 3rd Streets and on Lonsdale Avenue from 13th to 18th Streets, according to the plans on file in his office. And for the laying of that portion of the main sewer from Keith Road North to 19th Street and sewers on Lonsdale Avenue from 19th Street to City Limits, and on Keith Road and 8th Street from Forbes Avenue to Lonsdale Avenue, connections to 25' lots to be made by "Y" junctions.

Tenders to be lodged with the City Clerk by 12 o'clock noon on January 3, 1911. All constructions to be finished by the first of June next.

The Clerk reported that the assessment roll for 1911 had been returned to him by the Assessor on the 30th of November the date fixed by resolution of the Council.

On motion of Alderman Schultz seconded by Alderman McNeish, resolved that Court of Revision on the Assessment Roll be held in the City Hall on Thursday, 2nd of February 1911, at 2 o'clock in the afternoon.

Alderman Schultz and Alderman Smith were appointed to act along with the Mayor as the Court of Revision to revise and correct the Voters' List for 1911. The Court is to be held on Saturday 10th next at the City hall at 2 o'clock.

The Clerk was directed to inquire of the City Solicitor what persons are entitled to be placed on the Voters List.

On motion of Alderman Schultz seconded by Alderman Fowler, resolved that the Medical Health Officer be instructed to examine and report on the sanitary condition of the temporary school in the Stephenson Block.

The Clerk was directed to prepare and submit to the Council a Bylaw to regulate the erection of buildings with special provisions as to fire escapes.

The Chief of Police reported that acting under instructions received from the Mayor he investigated the report that Ed. W. Swan a sub=foreman on the water works had made use of men employed by the City to clear certain land in Lynn Valley and found that such was the case from information he had received. Mr. Swan had two men working there from September 10th to September 24th and their time was included in the City's payroll in the usual way. He had reason to

believe that Swan was now in Tacoma and it was his intention to go to Australia. The Chief of Police was instructed to consult with the City Solicitor regarding the prosecution of Swan.
