Reports and recommendations by the Finance (General, Police and School Trustees), Board of Works (General and Local Improvement), Water Works, Fire and Light and Public Health Committees on due Accounts were submitted and read to the meeting and the Treasurer was authorized to pay accounts to the amounts following, viz:

The Clerk reported that the Wallace Shipyards Aid Bylaw had been duly revised by the City Solicitor and published in yesterday's issue of the "Express".

The Mayor reported that he had taken the affidavits of the Indian Chiefs consenting to the release of the land required for street purposes through the Mission Reserve.

Alderman Irwin moved that the Mayor, all members of the Council, the City Engineer, the City Clerk, Ex-Mayor Kealy, Mr. William Maiden, Ex-Alderman Dick, Ex-Alderman Young, and any Officers or Members of the Ratepayer's Association be requested to attend the continued hearing before the Executive at Victoria on Wednesday next at 11 am. re Rice Lake and Lots 856 and 857.

A Bill of \$9.90 to George Prime for prisoner's meals was passed for payment.

The Mayor and Clerk were authorized to sign contract for Lonsdale Avenue Storm sewer.

Alderman McNeish moved that City Engineer be authorized to engage the services of a proper person to act as Inspector of Lonsdale Avenue Storm Sewer, his duties to come under the jurisdiction of the City Engineer wages at the rate of \$3.50 per day. The motion was seconded by Alderman McRae and agreed to.

The City Engineer reported that he was calling applications for an Assistant Engineer experienced in sewer work, paving and grading, salary at the rate of \$110 per month.

Mr. Salsbury submitted a communication received from his principals, inquiring whether issue of \$80,000 Debentures to purchase Ferry stock could be bought at \$100.55 or better.

On motion of Alderman McNeish seconded by Alderman Fowler, resolved that issue of \$80,000 be offered to Brouse Mitchell & Co. at the price of \$100.55 or better for acceptance not later than Wednesday.

On motion of Alderman Fowler and Alderman Irwin resolved that City bear half the cost of light at City Boundary on Lonsdale Avenue.

On motion of Alderman Irwin and Alderman Fowler, resolved that Council adjourn until 11;50 a.m. on Tuesday to receive and open Tenders for sewers and rock crusher.
