

MINUTES OF REGULAR MEETING OF CITY COUNCIL HELD WITHIN THE COUNCIL CHAMBER ON MONDAY, OCTOBER 27TH, 1913 AT 8 O'CLOCK P.M.

The Minutes of the Adjourned Meeting of the 24th instant copies of which were previously furnished to each member of the Council were taken as read and on motion adopted.

Correspondence was received, read and dealt with as follows:

From G. Lane et al requesting that the road on 19th Street from Williams Avenue to Rufus Avenue be repaired. Referred to Board of Works.

From C. Talbot Haslam, City Assessor, reporting to the Council that he had received title to fractional lots 15 and 16/134/274 and to a portion of the Hamersley Lanes in D.L. 274, and that the balance of the titles in respect to the lanes would in all probability be to hand in a few days. Referred to Lanes Committee.

From R. L. Reid, City Solicitor, advising the Council that a Municipal Council has no right by resolution to exempt any property from taxation, and that the only way that exemption from taxation can be given is by a Bylaw that must receive the assent of the Electors. Filed.

From Brown & Beaton submitting prices on Anti Diphtheria Serum and advising the Council that Mr. M.S. McDowell would handle the serum for their firm if it was the desire of the Council to purchase from them. Moved by Alderman Vance seconded by Alderman Pilling and resolved that the offer of Brown & Beaton be accepted.

From Mr. Jenkins, Secretary, North Vancouver & District Football League in respect to the City purchasing Recreation park, North Lonsdale, for recreation purposes. Referred to Parks Committee.

Alderman Allan then entered the Meeting.

Moved by Alderman Pilling seconded by Alderman Williams and resolved that the Squamish Mission Boarding School be requested to pay the difference between

the cheque they have presented to the City Treasurer for their taxes for the year 1913 and the total amount including rebate.

Moved by Alderman Allan seconded by Alderman Williams and resolved that a Bylaw be introduced and passed by the Council and submitted to the Electors at the next general election to be held in January for the purpose of determining whether or not the Squamish Mission Boarding School shall be exempt from taxation for previous years which at present remain unpaid and due.

Moved by Alderman Allan seconded by Alderman Wheeler and resolved that the Engineer be instructed to proceed with the improvement of Mahon Park as authorized under the provisions of Bylaw NO. 194.

Council thereafter adjourned.
