MINUTES OF ADJOURNED MEETING OF CITY COUNCIL HELD IN THE COMMITTEE ROOM, THURSDAY, JUNE 24TH, 1915 AT 8:00 P.M.

Pursuant to adjournment Acting Mayor Foreman called the Council to order at 8 o'clock P.M.

The matter of the request of Parkes Breweries, Ltd. for exemption from taxation of their industry to be established in D.L. 272 was considered and it was moved by Alderman MacDonald seconded by Alderman Biss and resolved that after consideration of the proposition placed before the Council by the Parkes Breweries Ltd. that this Council desires to place itself on record as being at all times desirous of assisting new industries proposing to establish in this City insofar as it can consistently do so, and that all applications, from parties proposing to establish such industries, for exemption from water and Municipal tax rates will at all times be most favorably considered.

Moved by Alderman Vance seconded by Alderman Biss that this Council now resolved itself into Committee of the Whole for the purpose of considering "The ferries Operation and Maintenance bylaw Amendment Bylaw".

IN COMMITTEE

Alderman Vance was appointed Chairman.

The Bylaw was considered.

Moved by Alderman Biss seconded by Alderman Kennedy and resolved that the Committee of the Whole now raise and report "The Ferries Operation and Maintenance Bylaw Amendment Bylaw" complete and recommend that the same be passed by the Council.

Whereupon Acting Mayor Foreman resumed the Chair.

Moved by Alderman Vance seconded by Alderman Biss and resolved that the invitation of the North Vancouver Board of Trade to be present at an address to be delivered by Major de Martin on Belgium at the Lonsdale Theatre on Friday, June 25th be accepted and as many of the Council as can make it convenient to attend, to do so.

Moved by Alderman Vance seconded by Alderman Biss and resolved that the invitation of Lewis D. Taylor, mayor of Vancouver, to attend the opening of Georgia-Harris Street Bridge at 11 a>M., July 1st, be accepted, and than mayor Taylor be reminded that a patriotic celebration will take place in North Vancouver on that date and to request him

to announce the fact at the opening of the bridge so that those present may have an opportunity to attend the Celebration in North Vancouver in the afternoon.

Moved by Alderman Vance seconded by Alderman Biss and resolved that the Mayor and City Clerk be and are hereby authorized to sign and execute on behalf of the City of North Vancouver can Agreement between the City and the Bank of Hamilton relative to cancellation and destruction of Debentures authorized to be issued under bylaw No. 290.

At 9:15 it was moved by Alderman Vance seconded by Alderman Biss and resolved that the Council adjourn.
