Correspondence was received and read and dealt with as follows:

From K. Lamond requesting to have their cheque which had been enclosed with their tender for hard surfacing returned to them.

Moved by Alderman W.J. Irwin seconded by Alderman Watson and resolved that the Clerk be and is hereby authorized to return the cheque to Kenneth Lamond, being the deposit with his tender for hard surfacing from the Ferry to the City Limits.

From Public Utilities Commission stating that the next hearing with respect to the six cent fare of the B.C. Electric Railway's street Railway System has been fixed for Monday the 18th instant, at 11 a.m. when all parties interested will be heard; also stating that copies of all proceedings can be obtained from the Official Stenographer. Moved by Alderman W.J. Irwin seconded by Alderman Watson and resolved that the Mayor and City Solicitor be and are hereby authorized to watch the above case in the interest of the City and secure copies of the proceedings.

From the B.C. Electric Railway Co. enclosing contract for lighting the Ferry premises on the Vancouver side. Referred to the City Solicitor to report to Council in connection therewith on the 18th instant.

From C.R. Lane, City Treasurer, being a report of Ferry Receipts and also report of cost of operation of the Ferries for the month of July. Receipts being \$22,324.82 an increase of \$4,516.54 over the corresponding month 1918, and being \$4,943.09 over cost of operation for the month, including depreciation and sinking funds and interest chargeable to Ferry Account.

Order filed.

From C.R. Lane, City Treasurer, reporting having received the balances of Treasury Notes issued under Bylaw No. 357 amounting in all to \$90,000 rate of exchange being 4 3/4%. Received and filed.

From C.R. Lane, City Treasurer, being Report of cost of Local Improvement Work on the Esplanade from Lonsdale to St. George's, total cost \$9,000. Referred to the Clerk and Engineer for purpose of completing Assessment Rolls.

From C.R. Lane, City Treasurer, being a report of Local Improvement work on St. George's Avenue from Esplanade to the Waterfront. Total cost \$700.00. Referred to the Clerk and Engineer for completion of the Assessment Roll.

From C.R. Lane, City Treasurer reporting that a cheque which had issued sometime since to the Land Registry Office, Vancouver has become lost or destroyed and a request has been received to have a duplicate issued. The Dist4ict Registrar having completed the necessary Indemnity Form for lost cheque, the Treasurer requested authority for the Mayor and Treasurer to issue duplicate cheque for the amount of \$15.96.

Moved by Alderman W.J. Irwin seconded by Alderman Watson and resolved that the Mayor and Treasurer be and they are hereby authorized to issue a duplicate cheque to Arthur G. Smith, District Registrar, in the Amount of \$15.96 to replace the one lost.

From C.R. Lane, enclosing a Tabulated Report of the returns of tickets sold by Mr. Phillippo at the Ferry. Net result being .63 cents too much turned in. Order received and field.

Reports and recommendations by the Board of Works, Health, Parks and Boulevards and Waterworks Committees on due accounts were submitted by the respective Chairmen and read to the Meeting and the Treasurer was authorized to pay the accounts to the amounts following:

Government that it will pay 50% of total cost of the work the tender of Columbia Bitulithic Limited for hard surfacing streets from Ferry Wharf to the Westerly limits of the City be accepted, in so far as it applies to work in the City at the price of \$1.85 per square yard and that the Solicitor be and is hereby instructed to prepare a contract for said work and the Mayor and City Clerk are hereby authorized to sign said contract on behalf of the City and the Clerk to attach the correct seal thereto.
