CERTIFICATE OF RETURNING OFFICER

Result of the Municipal Election held on the 9th and 12th of January A.D., 1922

I, RUPERT FOSTER ARCHIBALD, Returning Officer for the City of North Vancouver do hereby certify that as directed by Statute, I gave notice to the Electors of the City of North Vancouver on the 29th day of December, 1921, as required by law, to the effect that nominations for the Election of persons to repre0sent the said Electors, in the Municipal Council as Mayor and Aldermen, and the Election of four(4) persons to represent them as School Trustees, for two years, and the election of one (1) person to represent them as Police Commissioner for two (2) years, would be received by me at any time between the date of the Notice and 2 o'clock p.m., Monday, January 9th, 1922, and that at the expiration of the time appointed for the nomination of Candidates as aforesaid, no more Candidates stood nominated for Police Commissioner, than there were vacancies to be filled, and I therefore forthwith, proclaimed GEORGE DYMOND HOYLAND elected as Police Commissioner for the ensuing term.

There being however, more nominations than there were vacancies to be filled in the case of Mayor, Aldermen and School Trustees, a poll became necessary and such poll was granted by me and opened at 112 Esplanade West, on THURSDAY, January 12th, 1922, between the hours of 9 o'clock a.m. and 7 o'clock p.m., and that after the closing of the Poll, the votes were counted resulting as follows:

As directed by the Municipal Council of the City of North Vancouver for the year 1921, I caused certified copies of Bylaws entitled:

The vote polled in favor of the "City of North Vancouver Ferry Debenture Bylaw, 1921" and the "City of North Vancouver Local Improvement Debenture Assumption Bylaw, 1921", not having received at least three-fifths of the votes of the persons who voted on said Bylaws, I declared the said two Bylaws, as not having received the assent of the Electors.
