MINUTES OF ADJOURNED MEETING OF COUNCIL HELD IN THE COUNCIL CHAMBER, CITY HALL, MONDAY, APRIL 24th, 1922 AT 9:00 P.M.

From the City Treasurer, dated April 18th, being his report as Treasurer, which should have been presented along with the financial statement.

From Mayor Morden, enclosing copy of statement of case opposing the application of the B.C. Electric Railway Company, before the Federal Railway Committee.

From H.C. Canston, 513 - 16th Street East, applying for a sidewalk, approach or crossing from the north side of the street.

Referred to the Board of Works Committee and the Engineer for a report.

From George D. Ireland, Relief Officer, Vancouver, enclosing copy of telegram to the Dominion and Federal Governments re extending relief, also copy of reply from the Deputy Minister of Labour, Ottawa.

From the City Engineer, dated April 21st, reporting that the extension of the Forbes Avenue sewer outfall has been completed with the exception of the back filling, also advising that the discharge of sawdust from the cedar mills adjoining is passing into the channel and may cause difficulty at the outfall.

Freeman-Smith and said City and upon said new mortgage for \$1000.00 as a first charge against said lots being duly registered, the City is authorized to advance to said H.E. Freeman-Smith a further sum of Two Hundred Dollars.

Docherty forward circular letters to the parties who are in arrears in their payments.

Moved by Alderman Harron, seconded by Alderman McColl and resolved that the northerly portion of the fence at Mahon Park be removed and stored before May 24th.

The Chairman of the Board of Works Committee, reported that Smith Brothers are in a position to supply an additional 30,000 or 35,000 feet of sidewalk lumber at \$15.00 per thousand, delivered.

Moved by Alderman Martinson, seconded by Alderman McColl and resolved that the offer of Smith Brothers to supply an additional 30,000 feet or 35,000 feet of sidewalk lumber at the price of \$15.00 per thousand, be accepted.

Moved by Alderman McColl, seconded by Alderman Townsley and resolved that the Council do now adjourn. Whereupon the Council adjourned.
