The Minutes of Regular Meeting of Council, held August 21st, 1922, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman Townsley, seconded by Alderman McColl, adopted.

The Minutes of Adjourned Meeting of Council, held August 23rd, 1922, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman Watson, seconded by Alderman Martinson, adopted.

The Minutes of Adjourned Meeting of Council, held August 28th, 1922, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman McColl, seconded by Alderman Prior, adopted.

From the City Engineer, dated September 5th re proposed subdivision of portion of the property of the North Vancouver Land and Improvement Company, on Lonsdale Avenue, and from Lonsdale Avenue westerly on the Esplanade, being Lot "X", D.L. 271 and Lot "A", D.L. 274, recommending the approval of the Plan. Referred to Plans for approval.

From A.C. Lewis, Secretary, Canadian Deep Waterways and Power Association, advising that the annual meeting and convention of said Association will beheld at Welland, Ontario, on September 19th and 20th.

From the Fire Chief, dated September 2nd, being his report as delegate to the Convention of Fire Chiefs in San Francisco in August, also reporting that he was elected Vice-President of the Pacific Coast Association of Fire Chiefs for B.C.

Moved by Alderman McColl, seconded by Alderman Martinson and resolved that the above application be referred to the Board of Works Committee, with power to act.

From the City Treasurer, dated September 5th, with respect to cheque received from the Provincial Government, for this City's proportion of Liquor profits for the six months ending March 31st.

The report of the Parks Committee as contained in the Committee's Minutes of August 28th, 1922, was read and on motion of Alderman McColl, seconded by Alderman Martinson, adopted.

The report of the Ferry Committee as contained in the Committee's Minutes of August 28th, 1922, was read and on motion of Alderman Watson, seconded by Alderman Townsley, adopted.

Moved by Alderman Watson, seconded by Alderman Townsley and resolved that in case of duplicate payments of taxes, or other payments or similar errors, that the Treasurer be and he is hereby authorized to issue cheques, refunding same, when in proper order.

PLANS FOR APPROVAL

Moved by Alderman McColl, seconded by Alderman Townsley that the plan of subdivision of Lot "X", D.L. 271, and Lot "A", D.L. 274, owned by the North Vancouver Land and Improvement Company, , be approved.

A vote was taken as follows:

For the Motion: Aldermen Townsley and McColl.

Against ;Motion: Aldermen Watson, Prior and Martinson.

Alderman Watson was opposed to the principal of blind lanes.

The motion was declared lost.

Moved by Alderman Martinson, seconded by Alderman Watson and resolved that 23rd Street from Moody Avenue to the Boulevard be rough graded.

His Worship Mayor Morden reported that Mr. Lockhart could not have report on plans and specifications for proposed ferry, ready until Thursday of this week.

Alderman Prior stated that he was of the opinion that the city should have a time keeper on the job while repairs are being made to the Vancouver wharf.

Alderman Watson stated that it is the regular practise of the Ferry Superintendent to do so.

Moved by Alderman Martinson, seconded by Alderman Townsley and resolved that when this meeting of Council adjourns, that it stand adjourned until Thursday, September 7th at 8 p.m.

Moved by Alderman Martinson, seconded by Alderman Martinson and resolved that a resolution of Council, of August 28th, 1922, Page 86 of the Council Minute Book, with respect to granting of Ferry Tickets to the Mayor and Aldermen, be reconsidered.

Moved by Alderman Prior, seconded by Alderman Watson as an amendment to the original resolution, that ferry passes be issued to the Mayor and Aldermen in lieu of tickets.

The amendment was carried unanimously.

Moved by Alderman Watson, seconded by Alderman McColl and resolved that the draft contract between the City and Napier and Miller Ltd., be laid on the table until Thursday evening.

Moved by Alderman Watson, seconded by Alderman Townsley and resolved that leave be now granted to introduce at this meeting of the Council, a Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 14", and that the said Bylaw receive three readings at this meeting of the Council, and that the occasion for such three readings be deemed an urgent one within the meaning of the Procedure Bylaw. Whereupon the Bylaw was introduced and read a first time.

Moved by Alderman McColl, seconded by Alderman Watson and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 14", be now read a second time.

Whereupon the Bylaw was read a second time.

Moved by Alderman Watson seconded by Alderman Townsley and resolved that the Committee proceedings with respect to the Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 14", be dispensed with.

Moved by Alderman McColl, seconded by Alderman Prior and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 14", be now read a third time.

Whereupon the Bylaw was read a third time and passed by the Council.

Moved by Alderman McColl, seconded by Alderman Townsley and resolved that the report of the Treasurer re expenses of delegates to Conventions, for the current year, be filed.

Moved by Alderman Watson, seconded by Alderman McColl and resolved that this Council send two delegates to attend the Union of British Columbia Municipalities Convention and Good roads League at Kamloops, in October.

Alderman Prior voting against.

Moved by Alderman Townsley, seconded by Alderman Watson and resolved that Alderman Watson and Alderman McColl be said delegates to attend the Convention at Kamloops.

Moved by Alderman Watson, seconded by Alderman McColl and resolved that the Clerk communicate with all delinquents under Better Housing Scheme, with respect to payments in arrears.

At 10:15 p.m. it was moved by Alderman Watson, seconded by Alderman McColl and resolved that the Council do now adjourn, to reconvene in the City Hall, on Thursday evening, September 7th, 1922, at 8 p.m. Whereupon the Council adjourned.
