Mayor Morden reported having attended a meeting last week in Vancouver, of Municipalities affected by the "B.C. Electric Railway Passenger Rates Act" 2 Municipalities were not represented. An adjourned meeting had been held on the 13th inst., and a resolution passed to the effect that the Attorney-General be advised that the bill does not meet with the approval of the Municipalities, and that an opportunity be given for delegates from the Municipalities to be heard by the Parliamentary Committee, before the bill goes through the house.

Moved by Alderman Martinson, seconded by Alderman Watson and resolved that Mayor Morden be appointed a delegate from this Council, to go to Victoria if necessary, with respect to the B.C. Electric Railway Passenger Rates Act.

The Clerk submitted a bill before the house, to amend the "Highway Act" also to amend the "Hospital Act", also the "Electrical Energy Inspection Act".

Moved by Alderman Watson, seconded by Alderman McColl, and resolved that this Council go on record as opposed to the "Electrical Energy Inpseciton Act" as drafted, particularly with respect to Clause (16) and that a copy of this resolution be forwarded to the Premier, the Attorney-General, the Parliamentary Agent to the Union of British Columbia Municipalities, and to the Executive of the Union of British Columbia Municipalities.

Mayor Morden reported that a bill is coming before the house for Scenic Highway on the North Shore.

Moved by Alderman Watson, s d by Alderman McColl and resolved that His Worship Mayor Morden look into the matter of the above proposed bill while in Victoria.

Moved by Alderman Prior, seconded by Alderman Martinson and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 19" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. No. 536.

Moved by Alderman Watson, seconded by Alderman McColl and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1922, No. 20" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. No. 537.

Moved by Alderman Priorm seconded by Alderman Harron and resolved that the Bylaw entitled "City of North Vancouver Waterworks Amendment Bylaw, 1922" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. No. 538.
