

CERTIFICATE OF RETURNING OFFICER

Result of Municipal Election held on the 11th day of January A.D. 1923

I, RUPERT FOSTER ARCHIBALD, Returning Officer for the City of North Vancouver do hereby certify that as directed by Statute I gave notice to the Electors of the City of North Vancouver on the 29th day of December 1922, as required by law, to the effect that Nominations for the Election of persons to represent the said Electors, in the Municipal Council as Mayor and Aldermen and the election of three (3) persons to represent them as School Trustees, for two years, and the election of one (1) person to represent them as Police Commissioner for two years, would be received by me at any time between the date of the notice and 2 o'clock p.m., Monday, January 8th, 1923, and that at the expiration of the time appointed for the nomination of Candidates as aforesaid, no more Candidates stood nominated for Police Commissioner, than there were vacancies to be filled, and I therefore forthwith proclaimed ROBERT CHANCE elected as Police Commissioner for the ensuing term. There being however, more nominations than there were vacancies to be filled, in the case of Mayor, Aldermen and School Trustees, a poll became necessary and such poll was granted by me and opened at 122 First Street West, on Thursday, January 11th, 1923, between the hours of 9 o'clock a.m. and 7 o'clock p.m., and that after the closing of the poll the votes were counted resulting as follows:

As directed by the Municipal Council of the City of North Vancouver for the year 1922, I caused certified copies of Bylaw entitled, "Water Frontage Purchase Bylaw, 1922" to be published and posted as required by law together with notices appended thereto, that the said Bylaws would be submitted for a vote of the assent of the Electors at 122 First Street West, on Thursday, January 11th, 1923 between the hours of 9 o'clock a.m. and 7 o'clock p.m., and that the said vote of the Electors was taken on the said day resulting as follows:

The vote polled in favor of the "Water Frontage Purchase Bylaw, 1922" being at least three-fifths of the persons who voted on said Bylaw, exclusive of those which were rejected on the grounds specified under Section (79) of the "Municipal Elections Act" I declared the said Bylaw as having duly received the assent of the Electors.
