Owing to the absence of His Worship Mayor Donaghy at Victoria, it was moved by Alderman Stoker, seconded by Alderman Tolmie and resolved that Alderman E.H. Bridgman be and he is hereby appointed Acting-Mayor during the temporary absence of Mayor Donaghy. Whereupon Acting Bridgman convened the Council; and reported having been in conference with Solicitors and Representatives of the District of North Vancouver and of the Northern Construction Company; that word has been received from Mr. Long, from Toronto, that the new drafts of Bylaws in connection with Bridge are now in order, perfectly satisfactory.
