The Minutes of Regular Meeting of Council, held July 16th, 1923, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman Bridgman, seconded by Alderman Prior, adopted.

Alderman Townsley requested permission to express his sincere appreciation of the letter of sympathy forwarded to him by the Council during his recent illness.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that a suitable letter be drafted and forwarded to the proper authorities, conveying the sympathy of this Council in the death of President Harding.

The Clerk reported having secured from Mr. Baird today Certificate of Approval to Bylaw No. 581.

That the tender of Clarke & Stuart, for supplying Debentures \$220,222.00 City; \$251,000.00 District and \$630,000.00 Bridge & Tunnel Co., at the price of \$595.00 for all was accepted; delivery to be mad eon August 27th.

The necessary Declarations re validating of the Bridge Bylaws are being forwarded to Mr. Burnes, Solicitor for the Burrard Inlet Tunnel and Bridge Company who will forward same to Mr. Long.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the above report of the Clerk be received.

Correspondence was received, read and dealt with as follows:

Moved by Alderman Bridgman, seconded by Alderman Prior and resolved that the above application of B...A. Noble be referred tot eh Superintendent of Works, with power to act.

From Building, Plumbing and Sanitary Inspector, recommending that the 'Dick' Horse be sold as he has been out on grass all summer and his front legs have not improved.

Mr. McGougan of the Cedars Limited being present, addressed the Council. Whereupon Mr. McGougan informed the Council that his Company wished permission to use St. George's Street end and build a short Crib; they were not applying for an exclusive use.

Moved by Alderman Irwin, seconded by Alderman Prior and resolved that permission be granted Cedars Limited to construct a short Crib on the easterly thirty feet of St. George's Avenue Street and they to secure the permission of the Harbour Board – and such Cribbing to be the property of the City upon the Cedars Limited discontinuing to use same; subject to (90) ninety days notice; charge \$5.00 per month for docking privilege.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the Great West Sand & Gravel Company be granted similar privilege to that given Cedars Limited; the Great West Sand & gravel to use the westerly thirty feet of St. George's Avenue street end; charge \$5.00 per moth; subject o (90) ninety days notice.

The Clerk stated that in the event of such permission being granted, the V.O.N. requested permission to change their Tag Day from September 15th to September 1st.

Moved by Alderman Bridgman, seconded by Alderman Prior and resolved that permission be granted to tag on the streets and on the Ferries on September 8th in aid of the Children's' Aid Society of Vancouver; and that the V.O.N. be granted permission to alter their tag day from September 15th to September 1st.

Against the motion: Alderman Townsley, Alderman Bridgman and Alderman Irwin.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that Mr. Bert Ansen be permitted to address the Council. Whereupon Mr. Ansen requested that the Motor Licensing Bylaw be amended to provide that twelve licenses be issued under list "A".

Mr. Ansen in support stated that there have been times when there have been to taxis on the stand at the ferry wharf for fifty minutes – on July 4th there was no taxi on the stand at the ferry wharf from 10:20 a.m. to 11:20 a.m.

Mr. Bulger and Mr. Jones also addressed the Council.

Mr. Ansen submitted a petition, containing approximately 83 names, petitioning that if arrangements cannot be made for all Taxis to use the wharf stand that the number of spaces be fixed and filled in rotation.

A petition was also presented, signed by twelve persons, stating that their name had been signed to the above petition on a misunderstanding and requesting to have their names withdraw n from such petition.

Moved by Alderman Prior, seconded by Alderman Stoker that no action taken be taken in the above matter.

An amendment was offered:

Moved by Alderman Bridgman, seconded by Alderman Irwin that the petition of Mr. Ansen be referred to Committee of the Whole.

A vote was taken.

For the amendment: Aldermen Townsley, Irwin, Bridgman.

Against the amendment; Aldermen Stoker and Prior. The amendment was declared carried and the motion lost.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that accounts in connection with the Hon. Dr. King Banquet be paid, upon being O.K'd by Mayor Donaghy and Reeve Loutet, same to be charged one-third each to the City, District of North Vancouver and District of West Vancouver; and that accounts be forwarded to the District of North Vancouver and West Vancouver for their proportion.
