Minutes of Regular Meeting of August 6th, 1923, copies of which were previously sent to the Aldermen, were taken as read and on motion of Alderman Bridgman, seconded by Alderman Stoker, adopted.

The Minutes of the Special Meeting re Ferry Insurance, held in the City Clerk's Office on August 13th; copies of which were previously sent to the Aldermen, were read and on motion of Alderman Bridgman, seconded by Alderman Irwin, adopted.

Correspondence was received, read and dealt with as follows:

From the Superintendent of Lands, H. Cathcart, acknowledging receipt of a letter with respect to the Foreshore Rights fronting Street Ends. Filed.

From A.B. Kirwin, $612 - 4^{th}$ Street East, complaining of the water supply on the West half of Lot 24, Block 18, D.L. 273; suggesting that a larger pipe than one-half inch be put in.

Referred to Waterworks Committee.

From A.J. Tremeer, asking for sidewalk to house, 329 – 25th Street East. Referred to the Board of Works Committee.

From the North Vancouver School Trustees, presenting a detailed estimate of the sums required by the Board of School Trustees for special or extraordinary expenses, amounting to; completion of new High School \$12,500 and the grading area of grounds in the immediate vicinity of high school building and forming paths and roadways, \$1,500.00; total \$14,000.00.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the following resolution, authorizing the closing of the deal and the expense of the British American Bond Corporation on payment of interest and principal to the date of release being effected; that the City hand release of Lot 80, Block 235, D.L. 546 to the British American Bond Corporation, Limpid, and that this matter be referred to Mr. R.F. Dr. Verner at this point made verbal explanation that upon Mr. Proulx being quarantined for Samllpox, he advised Dr. Verner that he had no money and in view of this statement, Dr. Verner told Mr. Proulx that the City would pay this account.

It was thereby resolved that the City pay the amount of \$26.71 to the White Grocery and hand the bill to the Chief of Police, with instructions to the Chief to try and collect the amount of \$26.71 from Mr. Proulx.

From Miss May D. Lindsay, resigning her position as stenographer in the Collector's Office.

Resolved that Miss Lindsay's resignation be accepted.

From the City Collector, suggesting that he be authorized to call for applications to fill the position occupied by Miss Lindsay.

It was thereby resolved that Miss Rose, now employed in the Superintendent of Works office, report to Mr. Lane, and fill the place of Miss Lindsay.

It being further resolved that the Superintendent of Works be authorized t advertise in the North Shore Press, for a Male assistant, for his office, to take the place of Miss Rose and that the salary be \$100.00 per month.

From (Miss) Annie L. Jessup, with reference to reduction in her salary. Resolved that this communication be laid over until the return of Mr. R.F. Archibald, City Clerk.

The matter of an account for the stenographer in connection with the duties of the City Solicitor, A.C. Sutton, amounting to \$8.95 was considered.

Resolved that the City pay this account and that the Solicitor be requested to meet the Finance Committee, in connection with accounts of this nature, before incurring similar expense.

Dr. Verner being present gave a report of the health of the City for July and up to August 20th as follows:

- 2 cases of Smallpox in August;
- 1 case acute Hemorrhoids, operated on at North Vancouver Hospital and still in attendance;
 - 1 case of impetigo;
 - 1 case of Ringworm;

in all, Dr. Verner reported making 40 visits to various patients.

Re Larson's Hotel – monthly tenancy.

Resolved that Mr. Larson be advised that the City do not feel disposed to grant him a further tenancy beyond the end of September and that the Solicitor be instructed to advise Mr. Larson that his lease terminates on September 30th, 1923.

Re purchase of 250 sheets of Schedule "A" to the Waterworks Bylaw No. 279; the City Treasurer advising the Committee that Shoemaker, McLean & Veitch's price for same would be \$5.50.

Recommend that the Treasurer be and is hereby authorized to purchase 250 of these sheets from Shoemaker, McLean & Veitch for the price of \$5.50.

Re the matter of the Dominion Day Celebration Committee.

Mr. Dickinson appeared before the Committee, explaining that the creditor's of the Committee had decided to accept fifty cents on the dollar for payment of due accounts, and also submitted the accounts to the Council together with several letters from the Creditor's, agreeing to accept fifty cents on the dollar.

It was resolved and Mr. Dickinson agreed that he would turn over all Cups and Trophies outstanding to become the property of the City; and that the matter of paying these accounts, to the amount of \$280.23, be dealt with at the next Council Meeting.

Re Trades License Bylaw.

After explanation of Chief Stewart; advising that in his opinion it would be better to not make any changes respecting fees of this Bylaw; it was resolved on motion of Alderman Bridgman that this Bylaw laid on the table for two months; and that a notation be made on the Bylaw re Chief's suggestion.

Re letter from Kiwanis Club, asking for a porcelain fountain at the foot of St. Andrew's Avenue.

Resolved that this matter be left over to the Incoming Council.

Re Lot 4, Block 9, D.L. 265.

Resolved that the City give and the Proper Officers are hereby instructed to give Quit Claim to this Lot to the rightful owner and that the Collector be authorized to make the necessary changes in his books.

The Treasurer explained that owing to the break down of the Cash Register and that the machine supplied would only register to the amount of \$90.00, thereby causing a delay until the return of our own machine and the putting through of the monies received for taxes.

It was resolved that the Finance Committee be empowered to transfer several balances to Loan Account in the meantime.

It was moved by Alderman Irwin, and resolved that a full report of accounts form the District, for Hospital charges be submitted and that City Clerk, Mr. Archibald, bring in a report as to those who owe money.

Re letter from Messrs. A.E. Ames & Co., advising of an offer to sell tot eh City, for purchase with sinking funds, \$1,000.00 Province of Manitoba, Canadian Northern Railway, 4% Debenture Stock, maturing June 30th, 1930, at \$92.20, yielding about 5.35%; Also \$15,000.00 Dominion of Canada unconditional guaranteeing Canadian National Railway 5% equipment Bonds, maturing 1932, at \$99.00, yielding 5.14%; Also £5,718 Canadian Northern Railway, maturing 1958 at \$74.00, yielding about 5.10%.

Resolved that his be referred to the Treasurer for report.

From the British American Bond Corporation, offering for immediate acceptance £300 City of North Vancouver 4 1/2 % Bonds;

Referred to the City Treasurer, for report.

Moved by Alderman Bridgman and resolved that the appointment of Alderman Irwin as Acting Mayor during the absence of Mayor Donaghy from the City be confirmed.

Moved by Alderman Bridgman, seconded by Alderman Stoker and resolved that the following report and recommendation of the Ferry Committee be received and adopted:

Re letter from Mr. W.F. Marpole.

The Superintendent submitted a report from R. Marshall, re alleged accident to car No. 33348.

After explanation by the Superintendent, it was resolved that a suitable letter be sent to Mr. Marpole, and the Superintendent's explanation be accepted, and the damage paid.

Re letter from E.E. keeling, re damage to trousers.

On explanation by Superintendent Edmonds, who explained that he had seen Mr. Keeling after the accident, it was resolved that no action be taken until a bill is presented.

The Superintend reported that a lady ticket seller was leaving at the end of the month.

After considerable discussion it was resolved that the matter of appointing an assistant in the place of the above, be left in the hands of the Superintendent and the Ferry Chairman, with power to act.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that the following report and recommendation of the Board of Works Committee be received and adopted:

Re complaint of A.J. McCardin, re dumping of sidewalk planks and old tins on Lots 18 & 19, Block 132, D.L. 274.

It was resolved that Mr. McCardin be advised that the Superintendent of Works advises "that the sidewalk planks and tins were not dumped on Mr. McCardin's property, that it was all on the street allowance and no encroachment on any

property", and that a copy of the Superintendent's letter be forwarded to Mr. McCardin.

The Superintendent's report re road surrounding Victoria Park, of May 14th; which was laid on the table for three months; was read and it was resolved that this report lay over a further period, owing to funds being short for this purpose.

The following is report of the Superintendent of Works, dated August 15th, 1923:

"The Committee, consisting of Alderman Stoker, Chairman; Alderman Irwin, Alderman Prior and the Superintendent of Works, inspected the following applications for improvements on Saturday, the 11th instant.

- 1. Application by James E. Barter, North Shore Garage, Ltd., for improvements to sidewalk in front of their property, 121 1st Street West. The Committee recommend that the sidewalk be renewed except the two entrance runways which are to be repaired by the North Shore Garage Ltd.
- 2. Application by Amy Edwards, lot 15, Block 6, D.L. 548, 21st Street West, between Lonsdale and Chesterfield, for sidewalk to her property; a distance of about 142 feet.

The committee recommend that a 4 ft sidewalk be laid a distance of about 142 feet, at an estimate cost of \$54.00.

3. Application by Wm. Morgan, 318 – 14th Street East, for a load of crushed granite or screenings to cover work done by him on boulevard in front of his property.

The Committee recommend that as we have no screenings in stock, no action be taken.

4. (a) Re: Parking Cars in Mahon Park.

The Committee recommend that a 24 foot roadbed on Jones Ave., be opened up from 17th to 18th Street, and that a ditch be produced Southward to take off the surface water from draining into Park, and that parking arrangements be made at the N/E corner of the oval.

- (b) That 16th & Forbes be improved to give better access into rear of Park; estimated cost of "a" and "b", \$150.00.
- (c) That the Superintendent of Works bring in a report on a reasonable scheme to take care of the flood water which at the present time ahs become dangerous at the Drill Hall.
- Re overtime for Foremen.

The Committee recommend that the foreman be paid at the usual rate for overtime and no holidays allowed."

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that he following report of the Water Committee be received and adopted:

Re draft Act of Greater Vancouver Scheme.

Resolved that North Vancouver City Council feel that they are not quite in sympathy with the proposition and that Mayor Donaghy and Alderman Irwin draft a resolution; which was drafted as follows:

"City Hall, North Vancouver, B.C., August 20th, 1923; Mayor C.E. Tisdall, Chairman of Joint Committee, Greater Vancouver Water District, Vancouver: We beg to acknowledge receipt of your Committee's revised Draft of the proposed Charter designated "An Act to Incorporate The Greater Vancouver Water District", and also your request that our Council examine same and advise you as to our concurrence or otherwise.

First, we desire to express our appreciation of the work carried on by your Committee and to assure you that we are in sympathy with the main objects as set forth in the Draft referred to, save and except as hereinafter noted –

The City of North Vancouver is in the unique position of having an entirely separate system of Water Supply by direct Service Mains from the near-by Lynn Creek and does not at present obtain or require the benefit of additional supply from either the Capilano or Seymour Systems. The extreme Northern portion of this City having a higher altitude is supplied in part by the District of North Vancouver from their North Lonsdale or Mosquito Creek system, which is also a separate short-line system of supply.

On the other hand, the City of Vancouver and adjacent Municipalities South of Burrard obtain practically all of their supply from the Capilano and Seymour, and the supply mains from these systems are further distant from our City than our present supply mains from Lynn Creek.

Taking into consideration the topographical situation of the several sources of supply referred to and the most economical method of utilizing same to the best advantage of all concerned we are of the opinion that the City of North Vancouver should not at present bred included in the area to be embraced in your proposed Water District.

We also object to the extraordinary powers of expropriation as set forth in Section 29 and 30 of the proposed Charter in so far as they purport to authorize the expropriation of water rights, water records, or water systems in whole or in part which may be the property of any City or Municipal Corporation which is not a party to or included within the area of the proposed Water District.

We hold that the right of thus arbitrarily expropriating in whole or in part the Water Systems of any City or Municipality is or should be solely the prerogative of the Crown, in the right of the Dominion or the Province, exercisable only by Parliament or the provincial Legislature and that under no circumstances should these powers of eminent domain be delegated to any Corporation whether municipal or otherwise.

We trust your Committee will give consideration to and approve of our recommendations on these two points, which are of primary interest to our City by amending the draft of the proposed Charter as follows, viz:

- 1. Eliminate the City of North Vancouver from the list of Municipalities to be included in the proposed Water district.
- 2. Amend sections 29 and 30 by eliminating such powers of expropriation as pertain to the Water Records, Water Rights or Water Systems in whole or in part of any Municipal Corporation which is not embraced within the area of the proposed Water District.

We would also be obliged if your Secretary will mail to our City Clerk a copy of final revised Draft of proposed Charter as soon as available." (Signed H.C. Wright, Acting City Clerk).

Re letter from A.B. Kirwin, asking for a larger pipe than one-half inch; pointing out that four houses are using from one-half inch pipe and that the pressure is very low.

Resolved that the Superintendent of Works bring in a report in this matter.

Re: letter from J.G. Farmer, pointing out the lack of water available upon the high portions of the Main through Lynn Valley, suggesting that it is probably due to defective plumbing and waste in the City.

Resolved that the Building and Sanitary Inspector be and is hereby authorized to take this matter up and inspect all users of water, to try and detect the defective plumbing and waste, if any, with power to act; and further report to the Council.

Moved by Alderman Townsley, seconded by Alderman Tolmie and resolved that the following report and recommendation of the Fire and Light Committee be received and adopted:

That the report of the Fire Chief for the month of July be accepted and the report filed for reference.

Moved by Alderman Prior, seconded by Alderman Stoker and resolved that the following report and recommendation of the Parks Committee be received and adopted.

Re application of the North Vancouver Horticultural Society, asking that the rough grass be cut and the roadways generally cleaned up.

Resolved that the above request be granted forthwith.

Moved by Alderman Prior, seconded by Alderman Townsley and resolved that this Council do now proceed to resolve itself into Committee of the Whole and that Alderman Bridgman be Chairman.

Moved by Alderman Bridgman, seconded by Alderman Stoker and resolved that the above report and recommendation of the Committee of the Whole be adopted.

Recommend that the communication from the Board of School Trustees, re the detailed estimate of sums required by the Board of School Trustees for Special or Extraordinary Expenses of the total net amount of \$14,000.00, be referred to the Adjourned Meeting of the council, of August 27th, when a date will be set for receiving their estimate.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the Bylaw entitled "The City Officials amendment bylaw, 1923" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and Acting city Clerk and sealed with the Corporate Seal; No. 585.

Moved by Alderman Bridgman, seconded by Alderman Stoker and resolved that the Bylaw entitled "North Vancouver Trades License and Regulation Amendment Bylaw, 1923" be laid over for two months.

Moved by Alderman Tolmie, seconded by Alderman Townsley and resolved that the Bylaw entitled "The Motor Licensing Amendment Bylaw 1923, No. 2" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and Acting city Clerk and sealed with the Corporate Seal; No. 587.

Moved by Alderman Prior, seconded by Alderman Bridgman and resolved that the Bylaw entitled "North Vancouver Street Traffic Bylaw, 1923" be now reconsidered, finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Whereupon the Bylaw was read and reconsidered, finally adopted, signed by the Mayor and Acting city Clerk and sealed with the Corporate Seal; No. 586.

Moved by Alderman Townsley, seconded by Alderman Prior and resolved that leave be now granted to introduce at this meeting of the Council, a Bylaw entitled "City of North Vancouver Land Sales Bylaw 1923, No.14" and that the said Bylaw receive three readings at this meeting of the Council, and that the occasion for such three readings be deemed an urgent one within the meaning of the Procedure Bylaw.

Whereupon the Bylaw was introduced and read a first time.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw 1923, No. 14", be now read a second time.

Whereupon the Bylaw was read a second time.

Moved by Alderman Bridgman, seconded by Alderman Stoker and resolved that the Committee proceedings with respect to the Bylaw entitled "City of North Vancouver Land Sales Bylaw 1923, No.14" be dispensed with.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the Bylaw entitled "City of North Vancouver Land Sales Bylaw 1923, No. 14", be now read a third time.

Whereupon the Bylaw was read a third time and passed by the Council.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the Council do now adjourn until 8 p.m. Monday, August 27th, 1923.
