The Minutes of Regular meeting of Council, held in the Council Chamber, March 2<sup>nd</sup>, 1925, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman Irwin, seconded by Alderman Townsley, adopted.

Correspondence was received, read and dealt with as follows:

From the Secretary, Board of School Trustees, requesting the Board of Works Committee to inspect the condition of Boulevards surrounding Queen Mary School with a view to such improvement as may be considered feasible.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the above matter be referred to the Engineer for report and recommendation.

From the Secretary, School Board, complaining of excessive speed of autos passing Queen Mary School.

The Chairman of the Board of Works reported that signs have recently been installed at the Queen Mary School.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the above action of the Board of Works be approved.

From the Alexandra Orphanage, Vancouver, applying for permission to tag on the ferries on the same day as the City of Vancouver grants them permission to tag.

Referred to the Clerk to tabulate along with other applications for tag days.

From the City Solicitor, Vancouver, enclosing notice of application for license to store water in Burwall Lake.

Also communication from the Comptroller, Water rights, advising that a meeting in connection with the application to store water in Burwell Lake will be held in the Minister's Room at the Court House, Vancouver, at 10:30 a.m. March 24<sup>th</sup>.

Referred to Special Committee consisting of Mayor Donaghy, Alderman Vance, Alderman Cameron and the Solicitor and Engineer were requested to be present.

From the Liquor Control Board, acknowledging receipt of letter re no beer in the City of North Vancouver and stating that should any applications be received communication from the City Council will receive due consideration.

Filed.

From J.M. Bryan, M.L.A. enclosing copy of letter to the Secretary, W.C.T.U. advising that in the event of applications for a beer license, the North Shore bodies interested would receive due notice.

Filed.

From the City Solicitor, advising that under section 54, sub-section 65, the Council may pass a Bylaw for prohibiting and regulating signs, bill boards and hoardings of any kind.

Filed for reference.

From C.D. Harper, applying for a sidewalk to his new bungalow 632 Chesterfield Avenue, situate on lot 3, Block 113, D.L. 548.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the above application be referred to the Board of Works Committee with power to act.

From the City Solicitor, enclosing finding of Judge Ruggles in the matter of appeals against assessment.

The assessment on the North Vancouver Land and Improvement Company property was confirmed, the Company to pay costs amounting to \$199.00. The assessment on C.F. Todd waterfront lease was reduced to \$100.00 per foot, City to pay costs \$71.00. Edward Chapman assessment, lease on water to reduced to \$90.00 per foot, City to pay costs amounting to \$71.00.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the above costs against the City be paid.

From D. Holdsworth, Capilano, complaining of insulting language being used to he and his wife, by the driver of the West Vancouver stage on March 1<sup>st</sup>, also report from the Police Department reporting having interviewed the driver of the stage who denies having used improper language.

Filed.

From the City Solicitor, re Bewicke Avenue street end, advising that the Quit Claim dated December 21<sup>st</sup>, 1916, specifically states that the lands shall be used for Municipal purposes and for no other purpose.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the Northern Construction Company be notified that the Council cannot see its way clear to lease the Bewicke Avenue street end, owing to terms of the grant of the waterlot.

From T.C. Baird, advising having purchased the site and entire plant of the B.C. Walsh Lumber Company and applying for fixed taxation for 10 years, based on assessment of \$10,000.00

- (2) Free use of the street end of St. Andrew's Avenue during the business term of the mill.
- (3) Supply of water amounting to 3,500 gallons per day, advising that the plant will engage approximately 50 men per shift and agreeing to employ entirely white crew, giving every preference to residents of North Vancouver.

Referred to Committee of the Whole.

From the City Assessor, recommending that Lots 6 and 7, Block "F" of 2/1&2, 2/23 & 24, D.L. 547 be reserved from sale.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that the above recommendation of the Assessor be adopted and the above lots reserved for Park purposes.

From J.M. Gavey and W.H. Inkster, applying for a continuation of the sidewalk on the north side of 11<sup>th</sup> Street in Block 81.

Referred to the Board of Works Committee for report.

From the City Assessor, advising that there is a clerical error in the printed price list with reference to Lot 10, Block 157, D.L. 271. Price should be \$800.00 instead of \$500.00.

Moved by Alderman Vance, seconded by Alderman Bridgman and resolved that the price list be amended by inserting \$800.00 as the price of Lot 10, Block 157, D.L. 271 instead of \$500.00 owing to a printer's error.

From Robert Chance, 12<sup>th</sup> Street East, complaining of scale on large trees on the Boulevard in the 100 Block 12<sup>th</sup> Street East.

Referred to the Engineer and Parks Foreman.

From the Private Secretary, Prime Minister, Ottawa, acknowledging receipt of resolution endorsed by this Council that the present bonus to disabled and dependent pensioners should be permanently added to and made part of their pension.

Filed.

From the City Treasurer, enclosing report of Pacific Great Eastern Railway tickets sold by the ferries during the month of February, amounting to \$118.90. Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the Treasurer be and he is hereby authorized to issue cheque in the amount of \$118.90, Pacific Great Eastern Railway tickets sold during the month of February.

From the V.O.N. applying for permission to tag on the streets and ferries on April 4<sup>th</sup>.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the above application be granted.

From Alex Philip, enclosing notice of meeting convened by the Board of Trade of representatives of the North Shore City and District Councils, Executive Council of the Board of Trade and representatives ratepayers, to be held in the City Hall, on Wednesday, the 25<sup>th</sup> day of March at 8 o'clock p.m.

The Clerk reported having arranged for a meeting of the joint Councils on the 23<sup>rd</sup> instant, at 8 p.m. to discuss Municipal amalgamation and other matters.

The communication was laid over for the decision of the joint Councils at meeting on the 23<sup>rd</sup>.

From the City Solicitor, enclosing draft amendment to the lease of W.F. Smith of Refreshment Booths on ferries No. 2 and No. 3.

Moved by Alderman Tolmie, seconded by Alderman Townsley and resolved that the above draft amendment to lease between the City and W.F. Smith of Refreshment Booths on No. 2 and No. 3 be approved, the Mayor and clerk authorized to execute the same on behalf o the City and the Clerk to attach the Corporate Seal thereto.

From the City Engineer, re proposed sewer on Indian Mission Reserve, recommending that the Indian Department be requested to consider opening a road through the Indian Reserve in the vicinity of the waterfront.

Moved by Alderman Irwin, seconded by Alderman Tolmie and resolved that a copy of the above report of the Engineer dated March 12<sup>th</sup>, be forwarded to Mr. Perry, Indian Agent, with a request for a conference in the matter.

From the City Engineer, reporting the cost of paving on the north side of First Street from the Empire Theatre westerly to Rogers Avenue, \$2,000.00, Lots 20 to 28 inclusive, Block 156, facing on the proposed work. As the property on the south side of First Street paid for the macadamizing of the south side of First Street, Lots 20 to 28 should bear the cost of macadamizing the north portion of the street, which would therefore cost \$9.00 per foot frontage, the assessment could cover 15 or 20 years.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that a copy of the above report be forwarded to the petitioners with a request that they confer with the Engineering Department in the matter, with a view to petitioning for the work.

From the City Engineer, dated March 16<sup>th</sup>, re proposed improvements at City's Waterworks Intake, plan dated March 15<sup>th</sup>, 1925 estimated cost \$5,000.00. Referred to Water Committee.

From the City Engineer, recommending that no action be taken at present, re sale of dry cedar poles and shingle bolts in D.L. 855.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the above report and recommendation of the engineer be adopted.

From Major McLean, 6<sup>th</sup> Field Company, with further reference to application for a grant for a band, it has been found that an arrangement has been made amongst musicians in order to produce a high standard of music they have agreed not to turn out in numbers less than 24 and therefore the cost per concert would be \$104.00 instead of \$48.00.

Moved by Alderman Bridgman, seconded by Alderman Vance and resolved that the above matter be referred to the Mayor to take up with Major McLean.

From the City Solicitor, with respect to non-payment of rent for the month of March, by the tenant of the North Vancouver Hotel, advising that the furniture and furnishings are subject to distraint for rent.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the Mayor and Clerk be authorized to sign warrant of distress against the

occupant of the North Vancouver Hotel, such warrant to be addressed to the Chief of Police.

Petition signed by 17 persons was received for repairs to the lane in Block 97, D.L. 549-274 also repairs to 9<sup>th</sup> Street from 8<sup>th</sup> to St. Andrews.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that above petition be referred to the Board of Works with power to act.

Alderman Bridgman inquired if the Mail Carrier collecting mail from the corner boxes has any special privileges in the matter of use of the streets.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that this matter be referred to the Police Department.

TENDERS were received, read and dealt with as follows:

Tenders for coal for the ferries were received from Great West Sand & Gravel Co. and Lonsdale Coal and Supply Company.

Moved by Alderman Irwin, seconded by Alderman Tolmie and resolved that the above tenders be laid over for two weeks, that the Clerk bring up old reports of different coals and all possible information be gathered.

Communication was received from Alex Smith & Company stating that their client's offer and cheque still holds good for the purchase of Lots 12 and 13, Block 35A, D.L. 550.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the matter of sale of Lots 12 and 13, Block 35A, D.L. 550 be laid over for two weeks.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the offer of W.D. McFarland & Company on behalf of a client to purchase Lots 25 and 26 less North 10 feet, Block 53, D.L. 550 at list price \$200.00 and \$250.00 be accepted, purchaser to pay along with first cash payment, an amount equivalent to proportion of taxes for the current year.

Alderman Irwin not voting.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the offer of Irwin and Billings Co. Ltd., on behalf of a client to purchase Lots 1, 2, 3, 4 and 5, Block 232A, D.L. 546, at list price \$150.00 each, be accepted, purchaser to pay along with first cash payment and amount equivalent to proportion of taxes for the current year.

Alderman Irwin not voting.

Moved by Alderman Bridgman, seconded by Alderman Vance and resolved that the offer of Irwin & Billings Co. Ltd., on behalf of clients to purchase Lot 12, Block 10B, D.L. 550, list price \$125.00 be accepted, purchaser to pay along with first cash payment, an amount equivalent to proportion of taxes for the current year. Alderman Irwin not voting.

Tenders were received from Clarke & Stuart Co. Ltd., and G.A. Roedde Ltd., for binding the Collectors Rolls for the year 1925, both tenders being \$75.00.

Moved by Alderman Bridgman, seconded by Alderman Vance and resolved that the tender of Clarke & Stuart Co. Ltd., for binding the Collector's Rolls for the year 1925, at the price of \$75.00 be accepted.

Tenders were received form Burrard Dry Dock Co. Ltd. and B.C. Marine Engineers and Shipbuilders Ltd., for repairs to No. 2 Ferry, according to specifications prepared by the Ferry Superintendent.

The tenders were referred to the Superintendent for tabulation who reported that the tenders were slightly above his estimate, principally in unseen work; the tender of Burrard Dry Dock Co., being \$2001.00 work to be completed in 6 ½ working days; B.C. Marine Engineers' tender being \$2213.00 work to be completed in about 7 working days.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the tender of Burrard Dry Dock Co. Ltd., in the amount of \$2001.00 be accepted for repairs to No. 2 Ferry, in accordance with specification, work to be done to the satisfaction of the Ferry Superintendent.

Reports and recommendations by the Finance, School, Board of Works, Waterworks, Ferry, Fire and Light, Parks, Police and Health Committees, on due accounts were submitted by the respective Chairmen and read to the meeting and the Treasurer was authorized to pay the accounts to the amounts following:

Mr. Wm. Morden interviewed the Council, requesting that as the City is the owner of the Horticulture Grounds and the Bowling Club have a lease of a certain portion thereof, that the City install a toilet and basin on the grounds, approximate cost in his opinion would be \$125.00.

Moved by Alderman Irwin, seconded by Alderman Vance and resolved that the Engineer be instructed to submit estimate of cost.

Moved by Alderman Bridgman, seconded by Alderman Vance and resolved that in the event of the North Vancouver Hotel building becoming vacant, that the matter of placing a Caretaker in charge without pay, during vacancy, be referred to the Mayor with power to act.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the Clerk look up old estimates of cost of repairs to the old hotel to make same suitable for City Hall purposes.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the following report and recommendation of the Ferry Committee be adopted:

The Superintendent verbally recommended that 5 or 6 tons of one and one-half inch anchor chain cable be purchased.

RECOMMEND that the Superintendent be authorized to purchase approximately 5 or 6 tons 1 ½ inch anchor chain cable at the price of 5 ½ cents per pound.

RECOMMEND that the matter of carrying liquid air cylinders on the ferries be referred to the Solicitor.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the following report and recommendation of the Finance Committee be adopted:

RECOMMEND that the Clerk be authorized to purchase a Mimeograph machine.

Communication was received from Alex Philip, re distribution of commission on Ferry Insurance, stating that the members of the Association do not see their way clear to accede to the Council's request to place Henry Woods' name on the list. However, Mr. Philip offers to place his share of the commission at the disposal of Mr. Woods if the Council so wish.

RECOMMEND that the Clerk reply to the effect that the Council is not looking for charity, that this being City business and under the control of the Council, the Council resents the offer to contribute your own share to Mr. Woods.

Re McGurk Loan, Better Housing.

Communication was received from the Solicitor with reference to instructions.

RECOMMEND that this matter be laid over for statement from the Treasurer as to the amount paid.

Communication was received from H.G. Nichols, Vancouver, wishing to interview the Council or Committee, with a view to opening up Lynn Creek Zinc Mines on the west fork of Lynn Creek.

Mr. Nichols being present, addressed the Committee.

RECOMMEND that Mr. Nichols get in touch with Mr. DeGray, Provincial Health Inspector, Dr. Verner, M.H.O. and City Engineer.

Mr. Nichols stated that if the mines are developed, they will probably eventually employ from 200 to 300 men.

Communication was received from the School Board, stating that they will require funds for construction of the Lonsdale School annex at the beginning of June.

RECOMMEND that the matter of sale of bonds be deferred until next meeting of Council and that the Engineer report when funds will be required for hard surfacing from Moodyville to the Bridge.

RECOMMEND that Mr. D. S. Laverty be advised that the Council cannot consider renting Lot 26, Block 136, D.L. 271 at \$1.00 per month ground rent.

RECOMMEND that the matter of report on assessment costs be laid over until next meeting for a written report.

RECOMMEND that the monthly warrants be okayed by the Treasurer as to the correctness of calculation of total of the various amounts on each warrant.

The Chairman of Finance submitted a communication from the City Treasurer, with respect to dismissal of Miss Grierson. RECOMMEND that the communication be filed.
