MINUTES OF REGULAR MEETING OF COUNCIL, HELD IN THE COUNCIL CHAMBER, CITY HALL, MONDAY, AUGUST 17TH, 1925 AT 8:00 P.M.

The Minutes of Regular meeting of Council, held August 3rd, 1925, copies of which had previously been supplied each of the Aldermen, were taken as read and on motion of Alderman Irwin, seconded by Alderman Townsley, adopted.

Correspondence was received, read and dealt with as follows:

From the Registrar, County Court, Vancouver, being receipt for the registration of Bylaws 653 and 654.

Filed.

From W. Greenlees, Contractor, advising that the new ferry lead had been delivered to the City on June 20th and requesting that his deposit cheque be returned in the amount of \$254.00.

The Superintendent submitted certificate that the lead has been completed to his entire satisfaction.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the Treasurer be and he is hereby authorized to return deposit cheque \$254.00 to Mr. Wm. Greenlees, Contractor.

From Henry E. Wood, Trustee, Vancouver Oil Refining Company, advising having taken out a building permit and started operations for the construction of an oil refinery in Block 21, D.L. 265 and making application for the opening of First Street West of Bewicke Avenue to give access to Block 21.

Referred to the Board of Works and Engineer for report.

From the Vancouver Harbour Commissioners, requesting that the resolution of Council of July 6th, 1925, approving of location plan of Terminal Railway, subject to Harbour Board replacing the present traffic road through Moodyville, be amended by deleting the condition contained in said resolution.

Referred to Committee of the Whole.

From Geo. Wilson, Contractor, being application for a Building Permit for repairs to the North Shore Iron Works situated on Lots 9 and 10, Block 171, D.L. 274. Moved by Alderman Irwin, seconded by Alderman Vance and resolved that the above matter be referred to the Solicitor as to the liability of the City to issue a permit.

From R.J. Ausmun, applying for a Building Permit to Lot 10, Block 11A, D.L. 550, there being no water in this Block 0n 20th Street.

The Clerk reported that the Engineer's Department had advised that if water is laid from the corner of 19th and Queensbury to Lot 10, Block 11A, D.L. 550 cost would be approximately \$100.00 but if water is laid through Lot 16, Block 11A, D.L. 550 which belongs to the City and is now used for road purposes, cost would be approximately \$40.00.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the Building Inspector be authorized to issue Building permit.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that the necessary steps be taken to dedicate as a public street, Lots 11 and 16, Block 11A, D.L. 550 which lots belong to the City.

From the City Treasurer, enclosing report of passenger receipts due the Pacific Great Eastern Railway for the month of July \$1,300.30.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the Treasurer be and he is hereby authorized to issue cheque in the amount of \$1,300.30 passenger receipts due the Pacific Great Eastern Railway for the month of July.

From the Deputy Minister of Finance, Victoria, enclosing cheque for \$7,865.62 City's proportion of Liquor profits for the period ending March 31st, 1925, distribution being made in proportion to the aggregate number of days attended by pupils enrolled in the Day Schools.

Filed.

From the Pacific Coast Association of Fire Chief's, advising that the Convention will beheld at Seattle, September 21st to 24th inclusive, and suggesting that the Fire Chief be sent to represent this City.

Referred to Fire and Light Committee.

From the Secretary, Board of School Trustees, requesting that if necessary, before the opening of Schools in September, the Council authorize the cutting of the grass by the City's Mowing Machine on terms obtaining in previous years.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the Engineer be authorized if necessary, to have the grass cut in the various school grounds on the same terms as obtained in previous years.

From Robert McBride, inviting the Mayor and Council to attend a public meeting on Friday the 11th day of September at 10 p.m. in the Council Chamber, City Hall, New Westminster, amongst other maters to fix the assessment on farm lands, to ask that the right of appeal be restored to taxpayers, etc.

Moved by Alderman Irwin, seconded by Alderman Tolmie and resolved that the invitation be received and as many as can possibly make it convenient to do so, endeavour to be present on that occasion.

From Florence Hartley, Secretary Christian Science Church, North Vancouver, stating that as they intend beautifying the grounds around their new Church, they would be glad if the City would put in a suitable sidewalk.

Referred to the Board of Works Committee and Engineer for report.

From Mrs. Winnifred Martin, Secretary Ladies Auxiliary North Vancouver Hospital, conveying appreciation for grant of \$125.00 towards purchasing Sterilizing equipment.

Filed.

From the Secretary, Good Roads League, stating that the Convention will be held as formerly in conjunction with the Union of British Columbia Municipalities Convention, some time during September, and requesting that any resolutions be forwarded, also requesting that delegates be appointed.

Moved by Alderman Vance, seconded by Alderman Bridgman and resolved that the same delegates be appointed as may be appointed to attend the Union of British Columbia Municipalities Convention and that a resolution be forwarded with respect to the classification of Third Street from Lynn Creek Bridge to the Second Narrows Bridge as a Secondary Highway, for endorsation by the Good Roads League.

From the Amputations Association of the Great War, conveying gratitude for splendid support in their campaign for stabilization of pensions. Filed.

From J.R. Foster, offering to purchase seven dead trees in Mahon Park, five of which are standing and two lying down, offering \$25.00.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the above application and offer be referred to the engineer and Chairman of Parks Committee with power to act.

From the Secretary, Ratepayers Association, drawing attention to the condition of toilets in Mahon Park, recommending that they be closed until they are put in sanitary condition, also requesting to know if any progress has been made towards installing public convenience near the foot of Lonsdale, also requesting in formation why a Chinaman who has been operating a laundry in the 100 Block First Street East, has been refused a License.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the complaint re toilets in Mahon Park, be referred to the Chairman of the Parks Committee and Engineer.

Moved by Alderman Irwin seconded by Alderman Bridgman and resolved that the Engineer submit report with respect to the installation of public convenience at some point north of the Ferry gates.

The Clerk was instructed to forward a copy of recent amendment to the Laundry Bylaw defining area in which laundries can be operated.

From the Secretary, Horticultural Association, requesting that the Board of Works be instructed to clean up the Boulevard and grounds of the Horticultural Society. Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the above application be referred to the Board of Works with power to act.

Application was received from R.O. Boult to purchase Lots 3, 4, 6 and 7, Block 39, D.L. 552 or stating that he is willing to take Lots 3, 4, 6, 7 and 12 at the price of \$160.00 assuming the responsibility for the taxes on Lot 12.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the above offer as it stands be not accepted.

Moved by Alderman Vance, seconded by Alderman Bridgman and resolved that Lots 3, 4, 6, 7 and 12, Block 39, D.L. 552 be separated on the price list and posted for sale at \$40.00 each.

Communication was received from Alex Smith & Company advising that they have an offer from two clients each wishing to purchase half of Lot 18, Block 120, D.L. 548, list price of whole lot being \$900.

Moved by Alderman Vance, seconded by Alderman Bridgman and resolved that the City express its willingness to sell the whole Lot 18 to Messrs. Alex Smith & Company.

Tenders for supplying coal were received from the Great West Sand 7 Gravel Company and Lonsdale Coal & Supply Company.

Moved by Alderman Bridgman, seconded by Alderman Tolmie and resolved that the tender of the Great West Sand & Gravel Company for supplying 60 tons screened Nanaimo Wellington Lump coal at price of \$9.50 per ton, be accepted, their tender being the lowest.

Moved by Alderman Tolmie, seconded by Alderman Townsley and resolved that this Council do now proceed to resolving itself into Committee of the Whole. Alderman Vance was appointed Chairman.

Moved by Alderman Townsley, seconded by Alderman Tolmie and resolved that the above report of the Committee of the Whole be adopted.

Moved by Alderman Tolmie, seconded by Alderman Bridgman and resolved that the following report and recommendation of the Ferry Committee be adopted:

The City Engineer submitted a report dated August 17th on the best material and method of renewing the flooring and decking on the ferry wharves.

The Ferry Superintendent also submitted report for renewing the planking on the North Shore steel bridges for passengers, recommending the renewing with fir planking 3 x 6, finished with a covering of Tarvia X and crushed granite, estimated cost \$379.50.

RECOMMEND that the above report and recommendation of the Superintendent for repairs on the bridge be adopted, not to exceed \$400.00.

RECOMMEND that the Engineer prepare plan and specification and call for alternative bids to be submitted at next meeting of Council, for concrete top or bitulithic top in place of the wood block decking on the permanent roadway portion of the North Vancouver wharf.

Re extension of the South Shore ferry leads.

The Solicitor submitted letter from Mr. Bateman, Local Right-of-way and Lease Agent, C.P.R. suggesting that it would be advisable if

representatives of the Council or Ferry Committee called on the General Superintendent of the C.P.R.

RECOMMEND that the Ferry Committee and Solicitor meet with the General Superintendent of the C.P.R. and that the Clerk arrange a meeting.

The Superintendent reported with respect to light of the Refreshment Booth on the Vancouver wharf, that under the terms of the lease the Agent was to arrange with the B.C. Electric Railway Company to pay direct, his light account, that this account has been paid by the City and there has accumulated since the first of August 1924, to June 30th, 1925, the sum of \$290.00.

RECOMMEND that the above matter be laid on the table until next meeting.

RECOMMEND that the Treasurer be authorized to redeem 298 half-fare children's ferry tickets, purchased by the Pacific Great Eastern Railway in connection with the Eagles Picnic, amount \$7.45.

The Clerk reported having received notice from C. Calla having met with an accident at the ferry, breaking the bone in one foot. This matter has been referred to the Employers Liability Corporation, who verbally stated over the telephone that they did not consider that he had a claim against the City, after having interviewed some of the witnesses.

RECOMMEND that the action of the Clerk be endorsed in notifying the Employers Liability Corporation.

The Superintendent verbally reported that on August 14th, 1925, at 3 p.m. he had disrated Mr. McLaren, Chief Engineer and signed him on again as Second Engineer.

The Superintendent read copy of his letter to the Captain, instructing that Mr. McLaren be disrated.

Mr. McLaren, by permission, addressed the Committee stating that he had been in the service of the ferries for 14 years, 8 years as second and 6 years as Chief Engineer. He also stated that the log book on his boat had disappeared and had been returned to the boat from the Superintendent's office. Under Shipping Regulations, the Chief Engineer is solely responsible for the Engines and Boilers.

Mr. McLaren requested that he be reinstated as Chief Engineer.

Mr. Chalmers submitted a letter which was read, from the Federated Seafarers Union with respect to the dismissal of one of the employees. The letter stated that their men had been treated satisfactorily. Mr. Chalmers also stated that he had interviewed the Captain on the boat, the Secretary of the Engineer's Association and the Shipping Master and that all considered that he was justified in disrating Mr. McLaren.

The Mayor inquired what was the cause leading up to the final disrating of Mr. McLaren.

The Superintendent stated that they had been putting in a new apron and that he had met Mr. McLaren and told him that a man was coming down to put in brick. Nothing in his conversation to cause trouble with McLaren. It was distinctly understood by McLaren that the Superintendent was to enter in an order book, laying out any work that was required to be done.

Captain Spracklin being present, addressed the Committee and stated that he considers the Superintendent has been doing his utmost to maintain discipline in the service.

Mr. Reed, Secretary of the Engineers Association being present stated that he had heard there was trouble between Mr. Chalmers and Mr. McLaren and that he had interviewed Mr. McLaren trying to guide him in the matter, but that Engineer McLaren has not appealed to the Engineers Association.

RECOMMEND that the action of the Superintendent in disrating McLaren, be confirmed.

The Solicitor reported that a Mr. Thompson whose car ran into the Inlet has entered an action against the City.

RECOMMEND that the Solicitor be authorized to defend such action.

Moved by Alderman Bridgman, seconded by Alderman Vance and resolved that the following report of the Finance Committee be adopted:

Re arrears of water, North Vancouver Nurseries 17th Street East. The Collector reported that water rates had accumulated against the above Nursery and that two parties have taken an option on the property, with a view to purchase. The parties being present stated that Mr. Jones has until September 6th to pay up \$6000.00 and in the event of his not paying, they intend purchasing the property.

RECOMMEND that the matter of turning on water to the house at the North Vancouver Nurseries, be left in the hands of the Treasurer for adjustment.

Re Deemings, 15th Street East

RECOMMEND that Mr. Deeming be charged at the rate of double house rate, viz, \$24.00 if in accordance with terms of Water Bylaw and that the meter be taken out, retroactive to June 1924.

The Solicitor reported that an Order Nisi has been made in the foreclosure action against McGurk, the 30th January 1926, has been fixed as the last day for redemption.

RECOMMEND that this matter be laid on the table pending the completion of foreclosure proceedings.

RECOMMEND that the Municipal News of B.C. be advised that the Council can only see its way clear to subscribe for four copies at the present time.

The Clerk reported having received a request from the Provincial Board of Health for copies of Health Bylaws.

RECOMMEND that this matter be left in the hands of the Clerk.

The Building Inspector submitted report with respect to radiators, etc., in the North Vancouver Hotel.

RECOMMEND that an inventory be taken and report submitted o moveable property at the North Vancouver Hotel premises, also a report oaf the condition of the doors and windows, same to be signed by the Building Inspector and Lessees, pipes to be drained and windows and doors secured.

Communication was received from Mrs. Margaret Hughes, re water rates in the case of two houses owned by her.

RECOMMEND that the Clerk forward a proper letter to Mrs. Hughes.

Re cost of Health Department for the years 1923 and 1924. RECOMMEND that report on cost of administering the Health Department for the years 1923 and 1924, be left to the Chairman of Finance and Treasurer.

The Solicitor reported that an Order in Council has been passed dealing with the Grant from the Indian Department to the City of the street through the Mission Indian Reserve and he has applied to have the Quit Claim registered.

RECOMMEND that Messrs. R.P. Clark & Company be advised that the City is not considering investing sinking fund in the meantime.

RECOMMEND that communication from the Department of Indian affairs to the Treasurer with respect to Block 123, D.L. 271 be laid on the table until next meeting, the Treasurer to secure information in Vancouver re Local Improvement charges on Government property.

RECOMMEND that the interest and sinking funds re Burrard Inlet Tunnel and Bridge Company bonds guaranteed by the City, due September 1st, be paid.

Re \$180,000.00 Treasury Notes due October 1st.

The Chairman reported that he and the Solicitor had interviewed Mr. Baird, Inspector of Municipalities, who is prepared to support a private bill providing for 5 year debentures in the amount of \$150,000.00, the City to pay of in cash 430,000.00 and retire the debentures at the end of five years, providing each year, sinking fund and interest for this purpose.

Mr. Gray reported that the Solicitors of the Bank have been instructed to look into the legality of the matter of the Bank taking up the notes as they fall due and holding same until the private bill is passed by the legislature.

RECOMMEND that the Solicitor prepare private bill and submit to the Inspector of Municipalities and take all necessary steps required to be taken in the matter, with a view to passing of a private bill at the next session.

RECOMMEND that the matter of paying off overdraft, be left in the hands of the Finance Committee with power to act, if the Solicitors of the Bank report that Treasury Notes were legally issued.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the following report of the Board of Works Committee be adopted:

A letter was received from G. Cambie, 1535 St. Andrew's Avenue, complaining of his wife having met with an accident on the sidewalk on 15th Street between St. George's and Lonsdale.

The Engineer submitted report on having examined the sidewalk and finding same in fair condition. This sidewalk having been properly constructed in the first place.

RECOMMEND that copies of letters and report be sent to the Bonding Company.

Communication was received from G.L. Edwards and others re lane in Block 11A, D.L. 550.

RECOMMEND that the lane in Block 11A, D.L. 550 be opened up at an approximate cost of less than \$150.00.

Re 3rd and Heywood.

RECOMMEND that two suitable dangerous crossing signs be installed at this point.

RECOMMEND that the Management of the B.C. Electric Railway Company be requested to give warning in cases of cars coming out of the car barns.

Re 3rd Street and St. David's.

RECOMMEND that a suitable crossing sign be installed at this point.

RECOMMEND that the committee inspect 3rd Street and Bewicke owing to dangerous curves.

Re Ridgeway and 10th.

RECOMMEND that the Engineer submit report on making the road at this point, secure for vehicular traffic.

The Engineer reported that the hard surfacing on 3rd Street from Lynn Creek to Queensbury will be completed about August 19th.

Moved by Alderman Townsley, seconded by Alderman Bridgman and resolved that the following report of the Fire and Light Committee be adopted:

Communication was received from the District council inquiring with respect to installation of boundary lights at Shavington and Keith and Keith and Centre, the District requesting that the City pay maintenance cost.

RECOMMEND that the Committee inspect any street lights applied for.

Moved by Alderman Vance, seconded by Alderman Irwin and resolved that the following report of the Water Committee be adopted:

The Engineer reported under date August 7th, recommending the following water extensions:

RECOMMEND that the above report of the Engineer be adopted and the work authorized.

Report was received from the Publicity Committee appointed to interview the Vancouver Oil Refining Company, who had applied for right-of-way for pipe line down Bewicke Avenue.

The Committee reported that the Council approve in principle the establishment of their proposed industry. The Committee recommends to the Council that the pipe line right-of-way be granted for a term sufficient to make the Company feel safe in proceeding with their proposed expenditures. The Committee also recommend that permission be granted the Company to construct a wharf for berthing deep sea ships, the Company to make use of the existing wharf if it so desires, any wharf constructed must be approved under the Navigable Waters Protection act and all works must meet with the approval of the Fire Marshall and usual building permits will have to be taken out, the public to have access to the wharf when constructed with a proviso that the Company is to be inconvenienced as little as possible.

Moved by Alderman Irwin that the above recommendations be approved, the location of the pipe line to be approved by the Engineer.

Alderman Vance reported that new concrete dam at the Intake has been completed, work is proceeding on the settling tanks and a freshet now will not interfere with the tanks.

Reports and recommendations by the Finance, School, Ferry, Board of Works, Waterworks, Fire and Light, Parks, Police and Health Committees, on due accounts were submitted by the respective Chairmen and read to the meeting and the Treasurer was authorized to pay the accounts to the amounts following:

Moved by Alderman Tolmie, seconded by Alderman Vance and resolved that leave be now granted to introduce at this meeting of the Council, a Bylaw entitled "City of North Vancouver Land Sales Bylaw, 1925, No. 44" and that the said Bylaw receive three readings at this meeting of the Council, and that the occasion for such three readings be deemed an urgent one within the meaning of the Procedure Bylaw.

Whereupon the Bylaw was introduced and read a first time.

Whereupon the Bylaw was read a third time and passed by the Council.
