

**MINUTES OF ADJOURNED MEETING OF COUNCIL, HELD IN THE COUNCIL CHAMBER, CITY HALL, MONDAY, JANUARY 11<sup>TH</sup>, 1926 AT 7:30 P.M.**

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the Acting Mayor and Treasurer be and they are hereby authorized to issue cheque in payment of License fees for City cars.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that leave be now granted to introduce at this meeting of the Council, a Bylaw entitled "City of North Vancouver General Borrowing and Hypothecation of Taxes Bylaw 1926" and that the said Bylaw receive three readings at this meeting of the Council, and that the occasion for such three readings be deemed an urgent one within the meaning of the Procedure Bylaw.

Whereupon the Bylaw was introduced and read a first time.

Moved by Alderman Irwin, seconded by Alderman Townsley and resolved that the Bylaw entitled "City of North Vancouver General Borrowing and Hypothecation of Taxes Bylaw 1926", be now read a second time.

Whereupon the Bylaw was read a second time.

Moved by Alderman Cameron, seconded by Alderman Irwin and resolved that the Committee proceedings with respect to the Bylaw entitled "City of North Vancouver General Borrowing and Hypothecation of Taxes Bylaw 1926" be dispensed with.

Moved by Alderman Cameron, seconded by Alderman Irwin and resolved that the Bylaw entitled "City of North Vancouver General Borrowing and Hypothecation of Taxes Bylaw 1926", be now read a third time.

Whereupon the Bylaw was read a third time and passed by the Council.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the report of the Treasurer and Auditor on the Financial Statement be received and referred to the Chairmen of the various Committees for use at the annual civic meeting.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the reports of the City Engineer and Building and Sanitary Inspector be received and referred to the Chairman of the various Committees for use at the annual civic meeting.

The Acting Mayor informed the members of Council that the full audited statement will be submitted on the 21<sup>st</sup> instant.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that this Council express its appreciation of the efforts of the Auditor in the matter of having the financial statement completed at so early a date in January.

Moved by Alderman Cameron, seconded by Alderman Irwin and resolved that the matter of handing over cheque to the Auditor for work for the last quarter of 1925 be left with the Acting Mayor and Treasurer.

Moved by Alderman Townsley, seconded by Alderman Irwin and resolved that the Council do now adjourn, to reconvene in the City Hall at 7:30 p.m. on Thursday, January 21<sup>st</sup>.
