

CERTIFICATE OF RETURNING OFFICER

Result of Municipal Election held on the 14th day of January A.D. 1926.

I, RUPERT FOSTER ARCHIBALD, Returning Officer for the City of North Vancouver do hereby certify that as directed by Statute I gave notice to the Electors of the City of North Vancouver on the 31st day of December 1925, as required by law, to the effect that Nominations for the Election of persons to represent the said Electors as Mayor and Aldermen (3), and the election of persons (4) to represent them as School Trustees, and for the election of one person to represent them as Police Commissioner, would be received by me at any time between the date of the Notice and 2 o'clock p.m., Monday, the 11th day of January, 1926, and that at the expiration of the time appointed for the Nomination of Candidates as aforesaid, only one Candidate, namely William Lever Keene was nominated for the office of Police Commissioner, and forthwith declared the said office of Police Commissioner, and I forthwith declared the said William Lever Keene elected as Police Commissioner for the ensuring term (2 years) and returned his name to the Clerk of the Municipality.

More nominations were received by me than there were vacancies to be filled, in the case of Mayor, Aldermen and School Trustees, a poll became necessary and such poll was granted by me and opened at 115 First Street East, on Thursday, the 14th, of January, 1926, between the hours of 8 o'clock a.m. and 8 o'clock p.m., and that after the closing of the Poll the votes were counted resulting as follows:
