Moved by Alderman Bridgman, seconded by Alderman Cartwright and resolved that the insurance on the North Vancouver Hotel property be renewed among the agents, same amount as last year.

Moved by a, seconded by Alderman Townsley and resolved that this Council take a recess to permit the Ferry Committee to hold a meeting.

Whereupon the Council took a short recess.

At 8:20 p.m. His Worship Mayor Tolmie reconvened the Council.

Moved by Alderman Bridgman, seconded by Alderman Townsley and resolved that the following report of the Ferry Committee be adopted:

The Solicitor being present, reported having interviewed the compensation board with a view to obtaining the reports or copies of reports in the matter of Dodd, for reopening of his application for additional compensation. The Board would not permit its reports to o out

of its possession, nor furnish copies, but allowed Mr. Gray to read same and no doubt, Dr. Verner would also be permitted to inspect reports.

The Solicitor was instructed to furnish Dr. Verner with any information in his possession the matter, and that Dr. Verner be requested to report at next meeting of Council.

The Superintendent read reports from the Captain and Mate with respect to Mr. Dodd while in the employ of the Ferries.

RECOMMEND that the matter be left with the Superintendent to give light work to Mr. Dodd should any be available.
