Moved by Alderman Loutet, seconded by Alderman Irwin and resolved that the tender of North Shore Press for supplying 2,500 water notices at the price of \$11.25 be and is hereby accepted their tender being the lowest.

Moved by Alderman Irwin, seconded by Alderman Loutet and resolved that the tender of the North Shore Press for supplying 50 books in duplicate, tax certificates, at the price of \$11.75 be and is hereby accepted their tender being the lowest.

Annual reports from the City Engineer, Board of Health, Ferry Superintendent, fire Chief and Statement of Receipts and Disbursements were submitted.
