## CERTIFICATE OF RETURNING OFFICER

## Result of Municipal Election held on the 13<sup>th</sup> day of January A.D. 1927

I, RUPERT FOSTER ARCHIBALD, Returning Officer for the City of North Vancouver do hereby certify that as directed by Statute I gave notice to the Electors of the City of North Vancouver on the 30th day of December, 1926, as required by law, to the effect that Nominations for the Election of persons to represent the said Electors as Mayor (1), Aldermen (3), and for the election of persons (3) to represent them as School Trustees, and for the election of one (1) person to represent them as Police Commissioner, would be received by me at any time between the date of the Notice and 2 o'clock p.m., on Monday, the 10<sup>th</sup> day of January 1927, and that at the expiration of the time appointed for the Nomination of Candidates as aforesaid, only one Candidate, namely GEORGE HERBERT MORDEN was nominated for the office of Mayor, and I forthwith declared the said GEOGE HERBERT MORDEN elected as Mayor for the ensuing term, and returned his name to the Clerk of the Municipality.

Only three Candidates, namely ARCHIE LEROY CLEMENTS, AUSTIN ROBERT GARROD and ALBERT GEOGE PERRY were nominated for the office of School Trustees and I forthwith declared the said

Archie Leroy Clements Austin Robert Garrod, and Albert George Perry

Elected as School Trustees for the ensuing term (2 years) and returned their names to the Clerk of the Municipality.

More Nominates were received by me then there were vacancies to be filed, in the case of Aldermen and Police Commissioner and a poll became necessary, and such poll was granted by me at 111 First Street East, on Thursday, the 13<sup>th</sup> day of January, 1927, between the hours of 8 o'clock a.m. and 8 o'clock p.m., and that after the closing of the Poll the votes were counted, resulting as follows:

And that I forthwith declared <u>Edward Harry Bridgman, John Norman White</u> and <u>Harley</u> <u>Christian Erskine Anderson</u>, duly elected as Aldermen for the term of two years, and Robert Chance elected as Police Commissioner for two years, and until their successors have been duly elected.
