

**MINUTES OF ADJOURNED MEETING OF COUNCIL, HELD AT THE OFFICE OF THE CITY SOLICITOR, A.A. GRAY, ON SEPTEMBER 21<sup>ST</sup>, 1927 AT 5:30 P.M. PURSUANT TO ADJOURNMENT.**

Moved by Alderman Irwin, seconded by Alderman Cartwright and resolved that the Bylaw entitled "The City of North Vancouver Highways Dedication Bylaw No. 1, 1927" be now reconsidered.

Whereupon the Bylaw was read and reconsidered.

Moved by Alderman Townsley, seconded by Alderman Bridgman and resolved that the said Bylaw as read and reconsidered, be now finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. No. 887.

Letter was received from J. Loutet & Co. and J. Paine with respect to amending the Bylaw re no-parking on Lonsdale Avenue.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that the Solicitor draft a Bylaw prohibiting parking for a longer period than one hour between sunrise and sunset, on Lonsdale Avenue from the Esplanade to 8<sup>th</sup> Street. Cars proceeding north on Lonsdale to park the rear right wheel to be against the curb, proceeding down Lonsdale the front right wheel to be against the curb. Emergency brake to be on.

Re smoke and sawdust nuisance.

Moved by Alderman Bridgman re smoke and sawdust nuisance.

Moved by Alderman Irwin, seconded by Alderman Bridgman and resolved that the Board of Works have power to act in the matter of improving Moody Avenue north.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that a letter be forwarded to the Harbour Commissioners requesting that owing to the necessity of work being proceeded with at once on the tunnel under the Esplanade, that an interview

be granted this Council previous to the departure of the Chairman, this matter being of the utmost importance to the City of North Vancouver.

Moved by Alderman Bridgman, seconded by Alderman White and resolved that the application of Major Leslie for transportation on the ferries for North Shore men attending drills in Vancouver, be referred to the Chairman of the Ferry, Major Leslie to interview the Chairman, and that the matter be reported at next meeting.

Moved by Alderman Bridgman, seconded by Alderman Irwin and resolved that the meeting adjourn.
