

CERTIFICATE OF RETURNING OFFICER

Result of Municipal Election held on the 12th day of January A.D. 1928.

I, Rupert Foster Archibald, Returning Officer for the City of North Vancouver do hereby certify that as directed by the Municipal Council of the City of North Vancouver for the year 1927, I caused certified copies of Bylaws entitled:

“The City of North Vancouver Hospital Acquisition Agreement Bylaw, 1927”,

“The City of North Vancouver Hospital Loan Bylaw, 1927”, and

“The City of North Vancouver School Extraordinary Loan Bylaw 1927”

to be published and posted as required by law, together with notices appended thereto, stating that the said Bylaws would be submitted for a vote of the assent of the Electors of the City of North Vancouver, at 120 Esplanade West, and at the Horticultural Hall, 22nd Street and Lonsdale Avenue, both in the City of North Vancouver, on Thursday, January 12th, 1928, between the hours of 8 o'clock a.m., and 8 o'clock p.m. The said vote of the Electors of the said City of North Vancouver, was taken on the said day and resulted as follows:

The said Bylaw NOT having received at least three-fifths of the votes of the persons who voted on said Bylaw, exclusive of those which were rejected on the grounds specified in the “Municipal Elections Act” I declared the said Bylaw as not having duly received the assent of the Electors.
