

## CERTIFICATE OF THE RETURNING OFFICER

Result of Municipal Election held on the 17<sup>th</sup> day of January A.D. 1929

I, GEORGE SIMMERS SHEPHERD, Returning Officer for the City of North Vancouver do hereby certify that as directed by Statute I gave notice to the Electors of the City of North Vancouver on the 3<sup>RD</sup> day of January, 1929, to the effect that Nominations for the election of persons to represent the said electors as Mayor (1), Aldermen (3), and for the election of three persons to represent them as School Trustees, and for the election of one person to represent them as Commissioner of Police, would be received by me at any time between the date of the notice and two o'clock p.m., on Monday, the 14<sup>th</sup> day of January 1929, and that at the expiration of the time appointed for the nomination of Candidates as aforesaid, only one person, namely George Herbert Morden was nominated for the office of Mayor, and I forthwith declared the said George Herbert Morden elected as Mayor for the ensuing term of one year and returned his name to the Clerk of the Municipality, also that at the expiration of the time appointed for the nomination of Candidates only three persons, namely Archie Leroy Clements, Austin Robert Garrod And Albert George Perry were nominated for the office of School Trustees and I forthwith declared the said Archie Leroy Clements, Austin Robert Garrod, and Albert George Perry elected as School Trustees for the ensuring term of two years and returned their names to the Clerk of the Municipality.

More fomentations were received by me then there were vacancies to be filled, in the case of Aldermen and Police Commissioner and a Poll became necessary, and such Poll was granted by me and opened at 55 Lonsdale Avenue and at the Horticultural Hall, 22<sup>nd</sup> Street and Lonsdale Avenue, City of North Vancouver, on Thursday, the 17<sup>th</sup> day of January, 1929, between the hours of 8 o'clock a.m. and 8 o'clock p.m., and that after the closing of the Poll the votes were counted, with the following result:

duly elected as Aldermen for the ensuing term of two years, and adjourned the declaration of the election of a Police Commissioner until Friday, the 18<sup>th</sup> of January 1929, at the City Hall, at 9 o'clock a.m., the ballots cast by the electors were again counted and I declared

duly elected as a Police Commissioner for the City of North Vancouver for the ensuing term of two years.
