The Minutes of the regular meeting of Council held on Monday, February 1st 1932, together with the Minutes of a Special meeting of Council held on Thursday, February 4th 1932, the Minutes of a Special Meeting of Council, held on Monday, February 8th 1932, and the Minutes of a Special meeting of the Council, held on Wednesday, February 10th 1932, copies of which had previously been furnished to each member of the Council, were taken as read and on motion of Alderman Anderson seconded by Alderman Huggett adopted.

Correspondence was Received Read and Dealt with as follows:

From the Board of School Trustees requesting that an extension of time be granted on the date for receiving the current year's estimates for Ordinary School expenditures. Moved by Alderman Anderson, seconded by Alderman Huggett and resolved that the request be granted the Board if possible to file the estimates with the Council on or before Monday, February 22nd next. In the meantime, the Treasurer obtain from the Secretary of the Board the closest figures possible for submission to the City's Bankers with whom an interview is to be had during the week.

From the Secretary to the Federal Minister of Labour, acknowledging receipt of a letter together with copy of resolution passed by the Council, recommending the convening of an economic Congress for the purpose of considering ways and means of eliminating the causes of Unemployment.

From A.E. Munn, M.P. acknowledging receipt of letter together with a copy of the resolution relating to Unemployment sent to the Prime Minister by the U.B.C.M.
Received and filed.

From the Hon H.H. Stevens, Minister of Trade and Commerce, acknowledging letter with enclosed resolution from the U.B.C.M.

The Minister in reply sets forth in detail the advances made by the Federal Government to the Province to date and further expresses the readiness of the Government to meet advances in full of the agreement against approved vouchers.

Mr. Cobb, spokesman, said fifty five organizations and over one hundred delegates were to go to Victoria, to take part in the March, the circumstances of those they represented did not permit of them contributing any funds and the speaker pressed that a grant of \$15.00 might very properly be made by the City to the Association.

Moved by Alderman Wilson, seconded by Alderman Huggett and resolved that the Council hereby authorizes payment of the sum of \$15.00 by way of a grant to the North Vancouver Unemployed Association.

REPORTS OF COMMITTEES

Moved by Alderman Anderson seconded by Alderman Huggett and resolved that the following report of the Finance Committee be adopted:-

RECOMMEND that Mr. J.S. Rogers, be notified that the Council cannot see its way clear to interrupt foreclosure proceedings already instituted on the property at 128 13th

Street West, and that if the amount owing by him is not paid on or before April 2, 1932, title will pass to the City in which case it is recommended that the most favourable consideration possible be extended to Mr. Rogers in the event of his making application to repurchase the property.

A.E. Ames & Co., Vancouver, wrote advising that the present market price for Dominion of Canada, guaranteed G.T.R. 4% Perpetual Debenture Stock, paying interest quarterly, would be approximately 60 to 63.

RECOMMEND that the matter be discussed with Mr. Baird Supervisor of the Royal Bank of Canada and at that time the Finance Committee have power to act.

RECOMMEND that the offer of A.E. Ames & Co. to purchase at a price of 99.60 plus accrued interest \$2,400.00 Dominion of Canada 5 ½% Bonds due November 1, 1932 be not accepted.

RECOMMEND that the proposal of Mrs. A.S. Whitbourne, 3938 24th Avenue West, Vancouver to exchange Lot 9, of the Easterly 2.46 acres of Block 12, D.L. 550 for a parcel of property more favourably situated, be referred to the Chairman of the Finance Committee and the Assessor for report.

RECOMMEND that the necessary book entries be made debiting Relief account and crediting Water collections with the sum of \$4.50 being the water rates for the current half year due by Mrs. M.J. Parkin, (a City indigent), residing at 892-17th Street East, (The Medical Health Officer recommends that the water service be not discontinued).

RECOMMEND that upon hearing a delegation from the North Vancouver Board of Trade the application for a continuance of the annual grant based on membership, be referred to estimates, subject to a financial statement for 1931 being furnished.

Captain Cates and Mr. J. Rodger Burnes, representing the North Vancouver Board of Trade in regard to the amalgamation of the City and District of North Vancouver, together with a request for a prior redefinition of the boundaries of the District of North Vancouver running approximately from Second Canyon Easterly to Rice Lake Intake and then South to D.L. 865, then Easterly to the quarry at Deep Cove permitting all other lands (including the City Watershed lands) to revert to the Provincial Government.

RECOMMEND that the delegation be requested to submit a map showing the redefined boundaries and that the industrial and Publicity Committee further study the proposal and report.

Moved by Alderman Anderson, seconded by Alderman Huggett and resolved that the following report of the Ferry Committee be adopted:

RECOMMEND that the insurance on No. 3 Ferry covering Hull, Machinery, etc. and Protection and Indemnity Risks in the amount of \$80,000.00 be placed through the North Shore Real Estate Association subject to the same rates, terms, and conditions as are enjoyed under the existing policies.

RECOMMEND that the application from C.W. Calhoun, 942 Pender Street West, Vancouver, concerning advertising privileges on the City Ferries and Approaches be dealt with in Committee of the Whole.

RECOMMEND that the wages of J.A. Wilson, painter on the City Ferries be and are hereby reduced from the sum of \$6.00 per day to the sum of \$5.50 per day, effective March 1, 1932.

RECOMMEND that following the approval of the Steamship Inspector the docking of No. 3 Ferry be postponed until Monday, February 29th and that the change of dates be duly advertised.

Moved by Alderman Anderson, seconded by Alderman Huggett and resolved that the following report of the Board of Works Committee be adopted:

RECOMMEND that a crossing be laid from the North to the South side of the Street in the three hundred block, Eighth Street East, to provide suitable access to a new residence just completed by Mr. Victor Larson.

Moved by Alderman Anderson, seconded by Alderman Huggett and resolved that the following report of the Health Committee be adopted:

RECOMMEND that the Solicitor and Engineer take up with Colonel Fell the question of granting permission to deposit City refuse or rubbish on the waterfront of his property in a westerly direction from the City's holdings immediately West of Fell Ave.

MOTIONS AND NEW BUSINESS

1. Moved by Alderman Wilson, seconded by Alderman Cartwright and resolved that owing to the shutting down of so much work the services of a full time Engineer be suspended for 1932, and that in the meantime Mr. G.S. Hanes, be retained as a Consulting Engineer to take care of necessary Engineering work at a remuneration to be agreed upon, to take effect from March 1, 1932.

2. Moved by Alderman Anderson, seconded by Alderman Cartwright and resolved that:

WHEREAS an extraordinary condition of unemployment exists which has seriously reduced and restricted the earning power of the Taxpayer, and has produced a consequent reduction in the total amount of Taxes collected by the Municipality.

AND WHEREAS the Municipality, on account of reduced revenue is curtailing every civic expenditure and reducing Civic employee's wages and salaries, in an effort to accommodate the present financial condition.

AND WHEREAS the major liability of the Municipality, consists of Bonded Debt with interest thereon.

BE IT THEREFORE RESOLVED that we, the Council of the City of North Vancouver, request the Federal Government of Canada, and the Provincial Government of B.C., to enact legislation at the present sitting of the respective houses, to legalize a reduction in the amount of interest to be paid upon the said Bonded Debt, commensurate with reductions in salaries and wages during the period of this extreme depression.

3. Moved by Alderman Anderson, seconded by Alderman Cartwright and resolved that:

WHEREAS the general condition of unemployment throughout the country is becoming more pronounced.

AND WHEREAS the relief work undertaken by the government heretofore, has had as its principle objective, the supplying of sustenance, to thousands of able bodied unemployed men and women and their dependents.

AND WHEREAS the cost of financing such unemployment relief work, is placing an insupportable burden upon the Taxpayer.

AND WHEREAS within the ranks of the unemployed there are professional men, artisans, mechanics, and skilled tradesmen of every kind.

BE IT THEREFORE RESOLVED that we, the Council of the City of North Vancouver, request the Provincial and Federal Governments to direct the labour of the unemployed, to the cultivation and production of those commodities necessary to their own sustenance.

Moved by Alderman Anderson seconded by Alderman Cartwright and resolved that copies of resolutions numbered two and three be forwarded to the Secretary of the U.B.C.M. for consideration at the forthcoming Special Convention at Victoria.

UNFINISHED BUSINESS

RECOMMEND that matters outstanding in connection with the Pressure Pipe Co., salaries, free passes on Ferries and estimates, be referred to Committee of the Whole.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that this council do now resolve itself into Committee of the Whole.

Alderman Brown was appointed Chairman.

IN COMMITTEE

Moved by Alderman Anderson, seconded by Alderman Cartwright and resolved that the foregoing report of the Committee of the Whole be adopted.

Moved by Alderman Huggett, seconded by Alderman Page and resolved that the agreement as amended between the Pressure Pipe Co. of Canada Ltd. and the City for carrying out certain agreed upon works within the City of North Vancouver be approved and that the Mayor and City Clerk be and are hereby authorized to sign and execute same under the Corporate Seal.

Colonel Mitchell in retiring thanked the Mayor and Council for the courtesy extended through the negotiations.

Moved by Alderman Huggett, seconded by Alderman Cartwright and resolved that the Ferry Committee investigate why a change has been made on Sunday mornings in the hours of the ticket-sellers at the Vancouver Ticket Office, it being reported to Council that the ticket-sellers had not been reporting for duty on Sunday mornings until 9 a.m. instead of 7 a.m.

Moved by Alderman Wilson, seconded by Alderman Huggett and resolved that out of the annual revenue in respect of their attendance at meetings of Council and Committees, the Mayor's Indemnity for services rendered during the current year shall be the sum of \$1,200.00 and for each and every Aldermen shall be the sum of \$320.00 for services rendered and to be rendered during the year 1932.
