MINUTES OF THE REGULAR MEETING OF COUNCIL HELD IN THE COUNCIL CHAMBER, CITY HALL ON MONDAY, MAY 16th, 1932 AT 8:00 P.M.

The Minutes of the regular meeting of Council held on Monday, May 2nd, 1932, together with the Minutes of a Special meeting of Council held on Wednesday, May 4, 1932, and the Minutes of a Special meeting of Council held on Monday, May 9, 1932, copies of which had previously been furnished to each member of the Council, were taken as read and on motion of Alderman Brown seconded by Alderman Cartwright adopted.

Correspondence was Received Read and Dealt with as follows:

From the Registrar of the County Court, Vancouver, being receipt for Bylaws numbered:

- 1334 "City of North Vancouver Land Sales Bylaw, 1932, No.2."
- 1335 "City of North Vancouver General Borrowing and Hypothecation of Taxes Bylaw, 1932".

FILED

From Mrs. O. Lifton, 239 East 19th Street, applying for sufficient shrubs to plant 44 feet of boulevard in front of Lot C, Northerly portion of Lot 2, Block 17, D.L. 549.

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the application be referred to the parks Committee with power to act.

From the City of Niagara Falls, Ontario, requesting the cooperation of Council in a Dominion wide petition to the Provincial and Dominion Governments urging that the necessary steps be taken to inaugurate contributory unemployment insurance.

Moved by Alderman Anderson seconded by Alderman Brown and resolved that the communication be referred to the Committee of the Whole.

From the Municipality of Richmond, seeking the support of Council in a request to the dominion Government to enact legislation removing the time limit during which it is now

possible to institute deportation proceedings, so that persons who prove to be undesirables may be deported at any time after their arrival in Canada.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the application be referred to Committee of the Whole.

From the Engineer:

a) Stating that if the Vancouver Dock receives a sudden impact or thrust by one of the larger ferries, the central portion of the structure would collapse owing to the rotten and broken condition of the stringers, and recommending that a plan be prepared showing the amount of construction work required to place the structure in a safe condition.

Moved by Alderman Anderson seconded by Alderman Huggett and resolved that the recommendation be and is hereby adopted.

b) Recommending that the Blacksmith be employed on 5 half days per week instead of 5 days every alternate week.

Moved by Alderman Wilson seconded by Alderman Brown and resolved that the recommendation be and is hereby adopted.

c) Recommending that the dilapidated sidewalk adjacent to the "Williams building" at 4th & Lonsdale, be removed and replaced with a four plank walk lengthwise along the length of the building at an estimated cost of \$50.00.

Moved by Alderman Anderson seconded by Alderman Cartwright and resolved that the recommendation by and is hereby adopted.

From the North Vancouver General Hospital applying for an allotment of \$2,000.00 to the Hospital account. A similar request having been made to the District of North Vancouver.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the application be referred to the Finance Committee with power to act.

From the North Vancouver General Hospital requesting the Council to pass a resolution assuming liability for the expense of providing attendants, in excess of those provided by the Hospital, for any patients admitted from within the City limits who have become irresponsible for their actions and a menace to themselves and others.

Moved by Alderman Wilson seconded by Alderman Brown and resolved that the City assume liability, subject to the right of indemnity from the patients representatives for the extra care and attention given to City cases where the illness is likely to be accompanied by acts of violence.

From the local Captain of the Salvation Army applying for permission to hold a Tag day in the City in aid of the Self Denial appeal on Saturday, May 28, 1932.

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the permission be and is hereby granted, subject to the usual restrictions as to tagging on the ferries and the prohibition from house canvassing.

From the North Vancouver Unemployed Workers Association suggesting that milk be supplied to children attending the City schools daily at the lunch hour.

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the communication be referred to the Committee of the Whole.

From the North Shore Real Estate Association urging the Council to take some definite action towards relieving the burden that has been thrust upon property owners through the non-payment of rent by those who are unemployed and again suggesting that the City undertake to pay Water rates and Taxes where the landlord is not in receipt of rent.

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the Association be requested to furnish a list of individual cases to be dealt with under such an arrangement.

From the Kiwanis Club of North Vancouver inviting the Mayor and Members of the Council to their regular Dinner meeting on Tuesday, May 17th, Major H. Brown, President of the Vancouver Board of Trade is to address the Club on "Public Issues of the Day", charge .50 cents per plate.

Moved by Alderman Brown seconded by Alderman Wilson and resolved that the invitation be accepted with thanks and as many members of the Council attend as possible.

From the North Vancouver General Hospital advising that in the opinion of the Hospital Board, construction of buildings to be used for public purposes in the vicinity of the hospital is not advisable.

Moved by Alderman Anderson seconded by Alderman Huggett and resolved that the information be conveyed to the promoters of the two building schemes and the communication thereafter filed.

From Dickie and De Beck, Solicitors, Vancouver, acting for Messrs. G.W. Hobson and T.F. Phillip, the trustees for the Creditors, making formal application that the parties be allowed to assign their interest in the lease of Heywood Auto Camp to Mr. Donald Robinson White of 317 East 1st Street, North Vancouver, who intends to carry on the business.

Moved by Alderman Cartwright seconded by Alderman Wilson and resolved that the City accept an assignment of the existing lease interests in favor of Mr. Donald Robinson White, subject to the payment of the current years rent.

ENQUIRIES

Alderman Wilson draw the attention of Council to recent Press reports quoting an opinion from the Solicitor in regard to undertakings in the City to be carried out under the direction of a Professional Engineer. The reports that came under his observation recited in detail that part of the Solicitor's opinion regarding works on which a professional Engineer is ordinarily engaged but did not state that ordinary maintenance on the same class of work could be carried out by a foreman, or superintendent without violating the "Engineering Act".

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the Press in quoting from communications that come before the Council fairly publish all the facts and not a portion of the facts. In cases where the facts cannot be condensed for Press reports the communication, if used at all, should be quoted in full.

RECOMMEND that the Marine Insurance on Ferry No.4, in amount \$45,000.00 be renewed through the firm of Irwin & Billings Co. Ltd. Acting in conjunction with associated North Vancouver firms on the same terms, and conditions as existing policies.

Moved by Alderman Anderson seconded by Alderman Huggett and resolved that suitable Street sign be installed at strategic points in the vicinity of the General Hospital bearing the legend:
