MINUTES OF THE REGULAR MEETING OF COUNCIL HELD IN THE COUNCIL CHAMBER, CITY HALL ON MONDAY, OCTOBER 17, 1932 AT 8:00 P.M.

The Minutes of the regular meeting of Council held on Monday, October 3rd, 1932, copies of which had previously been furnished to each member of the Council, were taken as read, and on motion of Alderman Anderson seconded by Alderman Brown adopted.

Correspondence was received read and dealt with as follows

From the Vancouver Armistice Day Committee inviting the Mayor and members of the Council to attend "Remembrance Day" ceremony at the Cenotaph at 10.40 a.m. Friday, November 11, 1932.

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the invitation be accepted with thanks and the Armistice Day Committee advised in reply that our own ceremony will be taking place about the same time, but that any member of the Council who can conveniently attend the Vancouver ceremony will do so.

From the Deputy Minister of Marine acknowledging communication with reference to the matter of taxation on property of the Crown administered by the Vancouver Harbour Commissioners.

Moved by Alderman Wilson seconded by Alderman Page and resolved that the communication be received and referred to the Solicitor.

From Jack Loutet M.L.A. acknowledging copies of correspondence sent to the Hon. J.W. Jones, Minister of Finance, with regard to the relief of Unemployment.

Received and filed.

From A.E. Munn M.P., Federal Member, acknowledging copies of the same correspondence.

Received and filed.

From A.E. Munn M.P. acknowledging the endorsement of a resolution urging upon the Federal Government assistance in connection with the refloating of public debt by the issuance of Dominion currency and enclosing a copy of Hansard in which is noted the

Prime Ministers observations concerning inflation or deflation in the issuance of currency.

Moved by Alderman Anderson seconded by Alderman Brown and resolved that the communication be filed and copies of the Prime Ministers remarks be made available for each member of the Council.

From Jack Loutet M.L.A. acknowledging the same resolution and reiterating his views in favor of an issue of currency instead of borrowing in order to carry on Unemployment relief.

Received and filed.

From the Workmen's Compensation Board dealing with the basis upon which compensation is paid to inured workmen, and from the Solicitor dealing with the method used by the Board in fixing the rate of compensation in the case of Mr. Thomas Hutchinson.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the communication be considered in Committee of the Whole.

From the Pressure Pipe Company of Canada Limited submitting a list of the men employed by them at their North Vancouver plant during the month of September.

The Clerk reported that the details as furnished were in accordance with the agreement between the City and the Company.

Received and filed.

From the Pacific Salvage Company Limited submitting a list of workmen employed by them as their North Vancouver plant during the months of August and September 1932.

The Clerk reported that the number of hours worked by residents of the City of North Vancouver was somewhat short of the percentage required under the agreement.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the submissions be filed and the Company advised that in future they must live strictly up to the terms of the Agreement.

From the North Vancouver General Hospital applying for an allotment of \$175.00 towards the operating expenses of the Hospital with the advice that a similar request had been made to the District of North Vancouver.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the application be referred to the Finance Committee with power to act, subject to equal payment by the District.

From the B.C. Amateur Lacrosse Association applying for a donation in cash towards the traveling expenses of the Squamish Indian team who are on a trip in Eastern Canada.

Moved by Alderman Anderson seconded by Alderman Page and resolved that Mr. J.A. McConaghy be heard on behalf of the application.

The Speaker explained that the main portion of the expenses were to be borne by the Dominion Association plus the gate receipts, but that no provision had been made for meals and other incidental expenses. Mr. McConaghy pictured the team as truly great and being composed of an athletic group of B.C. Coast Indians practically all of whom were resident in North Vancouver. It must please the Council that the team was well in the running for Dominion Lacrosse Championship honors, and a cash grant from the City at this time would help considerably in keeping up the morale of the boys.

His Worship the Mayor pointed out the difficult financial position in which the City found itself and while recognizing the fine sportsmanship of the team it was hardly possible at this time to comply with the request, he would, however, see what could be done amongst the members of the Council.

The matter was thereupon left in the hands of His Worship the Mayor.

From the Union of B.C. Municipalities applying for a second assessment of \$50.00 towards the expenses of the Union on account of the heavy work carried out this year, and from the President submitting a report on the recent Conference held in the City of Victoria.

Moved by Alderman Anderson seconded by Alderman Cartwright and resolved that the application be referred to the Finance Committee with power to act and the report filed for reference.

From the B.C. Electric Railway Co. Ltd. submitting copy of an application made to Dr. S.F. Tolmie, Premier and Minister of Railways, Victoria, for permission to operate one-man street cars on the Capilano and Lynn Valley lines of the North Vancouver system.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the Council go on record as being unalterably opposed to the operation of one-man cars in the City of North Vancouver and that the Solicitor Clerk and Engineer, review all protests and correspondence filed on former occasions in order that effective measures may be taken to retain the present service which is considered essential to maintain a service that will meet the ferries and that the cooperation of the local member, Mr. Jack Loutet be sought in jointly protesting the application at Victoria with the City.

From the Star meter Cab Limited, Vancouver, applying for taxi-cab space at the Vancouver Ferry Terminals.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the application be referred to the Ferry Committee for study and report from the Solicitor and Engineer.

From the Canadian National Institute for the Blind advising that Mr. M.C. Robinson, Superintendent, is absent in Alberta and that the Council's most recent request will be placed before him on his return at the end of the present month.

Moved by Alderman Wilson seconded by Alderman Huggett and resolved that the correspondence be laid on the table.

The following applications for external sidewalks to new residences were submitted:-

Moved by Alderman Wilson seconded by Alderman Cartwright and resolved that the applications be referred to the Board of Works Committee for report.

From the Engineer recommending that the wooden sidewalk be lowered 8 to 10 inches in front of Harron Bros. Undertaking Parlors and that the Boulevard between this point and Lonsdale Ave. be sloped off and the side of the roadway graded so that care may be parked without going into the ditch. Estimated cost \$30.00.

Moved by Alderman Brown seconded by Alderman Cartwright and resolved that the recommendation of the Engineer be and is hereby adopted.

From the North Vancouver Health Unit submitting a report and statistical statement for the month ending August 1932.

Moved by Alderman Anderson seconded by Alderman Brown and resolved that the report and statement be referred to the Health Committee for consideration.

From the North Shore Cricket Club submitting a financial summary and statement covering the 1932 season together with a statement of the estimated expenditure for 1933.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the 1932 operations be studied by the Parks Committee and the 1933 figures referred to Estimates.

A copy of a letter from His Worship the Mayor to the Royal Bank of Canada regarding finances for the balance of the year was tabled for consideration at the same time as the reading of the Bylaw to implement same.

From the Women's Auxiliary of the local branch of the Canadian Legion applying for permission to sell tags on the City Ferries on Saturday, November 5, 1932.

Moved by Alderman Wilson seconded by Alderman Huggett and resolved that the permission be and is hereby granted.

From the North Vancouver Unemployed Association with regard to the issuance of Relief orders and the upward tendency in commodity prices.

Moved by Alderman Anderson seconded by Alderman Wilson and resolved that the Relief Officer bring in a report bearing on the situation.

From the local Unit of the Army & Navy Veterans Association inviting the Mayor and members of the Council to attend the Memorial Service at the Cenotaph at 11 am Friday, November 11, 1932.

Moved by Alderman Brown seconded by Alderman Huggett and resolved that the invitation be accepted with thanks and as many members of the Council attend as possible and that His Worship the Mayor on the occasion place a wreath on the Cenotaph on behalf of the City.

From Paul Johnsons' Advertising Service applying for the right of distributing free of charge to passengers on the City ferries a weekly publication entitled the "Fog Horn".

Moved by Alderman Wilson seconded by Alderman Brown and resolved that the application be referred to the Ferry committee who will meet with the applicant at the Ferry office on Wednesday, October 19th at 4 p.m.

ENQUIRIES

Alderman Huggett enquired if permission had been granted to erect an unsightly fence on the southeast corner of 9th St. and the Boulevard.

The Clerk reported that following complaint the Building Inspector had been in touch with the party who was erecting the structure and it was found that the owner was reconstructing a tennis court already established, which it also appeared was contrary to Boulevard restrictions and the "Fences Regulation Bylaw".

Moved by Alderman Huggett seconded by Alderman Page and resolved that the Engineer & Building Inspector examine and report.

RECOMMEND that the Ferry Profit & Loss account as at September 30th last showing on operating surplus of \$58,063.60 be received and filed. <u>Figures not to be given out for publication</u>.
