Under authority of the Commissioner the Clerks of the City & District appointed Mr. E.N. Maltby as outside collector of Road & Poll Taxes, Water rates arrears, Dog Licenses, Ambulance calls and sundry accounts payable on a commission basis.

Introduction and three readings of Bylaw No.1369 being a Bylaw to dedicate as Public Highways, certain lands within the City of North Vancouver.

RESOLVED that an estimated revenue of Two Hundred and Eighty Thousand Dollars (\$280,000.00) from the City ferries for the year 1933 be and is hereby approved.

and be it further resolved that a bylaw be prepared and submitted to the Commissioner based on the aforementioned rates and that a graduated penalty of 10% be imposed in the following manner:-

On and after August 1st, five (5%) shall be added to the amount of the current years taxes unpaid. On October 1st, three (3%) and on Dec. 1st, two (2%). So that the aggregate of the percentages to be added as aforesaid shall be ten (10%) of the amount of the tax imposed.
