The following appointment was made to the Ferry Staff – John McPherson, Bookkeeper at a monthly salary of \$120.00, services terminable on one month's notice and duties to begin on January 13<sup>th</sup>.

- 9<sup>th</sup> Advised a number of petitioners that a reduction in water charges was impractical at the present time.
- 11<sup>th</sup> Awarded contract for pipe and other waterworks materials to Crawley and Barker at a price of \$432.94 (low of four tenders).
- 13<sup>th</sup> Effective today Mr. Hanes was relieved of the combined duties of City Engineer and Ferry Superintendent. Appointed Mr. George Chalmers as Ferry Superintendent to take over all of the duties customarily performed in that regard at a salary of \$200.00 per month and Mr. Hanes the duties of a full time Engineer for the City and Consulting Engineer for the District at a salary of \$150.00 per month.

Advised by Mr. Lionel H. Lindsay, Supervising Examiner of Masters and Mates, Western Division, of a preliminary enquiry into the cause of the collision between M.S. "BRYNJE" and the North Vancouver Ferry No.2 on last December 16<sup>th</sup>.

14<sup>th</sup> Received report of the Health Unit for the month of December 1935, indicating that the general health of the community had improved during the month, communicable diseases had dropped off satisfactorily, and there is nothing of an epidemic nature within the Municipality at the present time. There are a number of colds and other minor illnesses among school children by nothing of very great importance.

- 14<sup>th</sup> At the request of the Minister of Education & Health, Dr. Amyot was granted three months leave-of-absence to do special work for the Provincial Government. Dr. Stewart Murray was appointed to act in the absence of Dr. Amyot at the same net salary per month.
- 15<sup>th</sup> Approved application of E.C. Schulz, A.J. Shannon and W.H. Rogers for the renewal of taxi licenses for the six-month period ending July 15, 1936. Permits issued under the terms of the "Motor Licensing Bylaw, 1920".
- 16<sup>th</sup> Approved a Grant to the local branch of the Canadian Red Cross of approximately \$40.00 to cover 50% of milk costs for the month of January pending an interview with the Vancouver Welfare Federation for a restoration of the grant recently discontinued by that body.
- 17<sup>th</sup> Submerged automobile found within the Vancouver Ferry Circle landing bearing B.C. License #75331 in which was found the body of Mr. P. Whithead. On suggestion of Mr. J.A. Young, representative of the Employers Liability Assurance Corporation instructed Farris, Farris, Schultz & Bull to attend the inquest and act on behalf of the City.
- (6<sup>th</sup>) Introduction and three readings of Bylaw entitled "The City of North Vancouver Prepayment of Taxes Bylaw, 1936".
- (13<sup>th</sup>) Reconsideration and final passage of Bylaw entitled "The City of North Vancovuer Prepayment of Taxes Bylaw, 1936".
- 18<sup>th</sup> On representation from the Employers' Liability Assurance Corporation Ltd. Instructed Farris & Co. to attend the inquest to be held into the death of Philip Whitehead whose body was found on January 16<sup>th</sup> in the waters of Burrard Inlet at the Vancouver Ferry Circle Landing in a Motor Vehicle bearing B.C. License No.75331.
- 20<sup>th</sup> His Majesty King George V died today.
- 21<sup>st</sup> Accession to the throne of His Majesty King Edward VIII.
