Meantime the present owners of the property who had no knowledge of the circumstances are to be notified by registered mail that in the event of further stoppage they will be required to connect at their own expense with the sanitary sewer laid on 5th street.
- 11th Purchased for Sinking Fund Investment from C.M. Oliver & Co., Victoria \$1,000.00 city of North Vancouver 5% Bonds due July 10, 1961 at 26 flat.
- 12th The Medical Health Officer reports as follows: "That North Vancouver City and District has been and still is experiencing and epidemic of influenza. This has necessitated considerable absence from School and is reflected in the attendance percentage.

- Approved the application of John Smith, Board of Works Foreman, to become a contributor to the Superannuation Fund at the rate of 8% per annum, effective April 1, 1936.
- Walter B. Harwood, 148 East 13th St., admitted on recommendation as a City expense to the Provincial T.B. Unit in Vancouver.
- 30th Advised by the Board of Railway Commissioners of Canada that the Vancouver Harbour Commissioners' application for a revision of the tolls to be charged in respect of the Second Narrows Bridge at Vancouver was approved and became effective March 9, 1936, Order No.52916.
