TO HIS HONOUR THE LIEUTENANT-GOVERNOR IN COUNCIL:

The undersigned has the honour to REPORT:-

THAT on the 27th day of September 1932, an Order was made by Mr. Justice D.A. McDonald, a Judge of the Supreme Court of British Columbia, authorizing the appointment of a Commissioner for The Corporation of the District of North Vancouver, pursuant to Part XXIII of the "Municipal Act" as amended by the "Municipal Act Amendment Act, 1932".

AND THAT on the 13th Day of January, 1933, an Order was made by the Chief Justice of the Supreme Court of British Columbia, authorizing the appointment of a Commissioner for The Corporation of the City of North Vancouver, pursuant to the said Part XXIII of the "Municipal Act".

AND THAT by an Order-in-Council approved 30th day of June 1934, John Villiers Fisher of Victoria, B.C., was appointed Commissioner for the Corporation of the District and City of North Vancouver:

AND THAT John Villiers Fisher has resigned his position as Commissioner for the Corporations of the District and City of North Vancouver which has been accepted to take effect today:

AND TO RECOMMEND that pursuant to section 472 of the "Municipal Act" as enacted by section 19 of the Statutes of B.C., 1932, the appointment of the said John Villiers Fisher as Commissioner for the Corporations of the District and City of North Vancouver respectively be cancelled:

And that George Washington Vance of the City of North Vancouver, B.C., be appointed Commissioner for the Corporation of the District of North Vancouver and the Corporation of the City of North Vancouver respectively in the place of the said John Villiers Fisher:

AND THAT the salary of the said GEORGE WASHINGTON VANCE as such Commissioner of the Corporation of the District of North Vancouver be Fifteen Hundred dollars per annum, and as Commissioner for the Corporation of the City of North Vancouver be Twenty-one hundred dollars per annum to be paid out of the respective municipal revenues:

AND THAT a certified copy of this minute, if approved, be transmitted to the said GEORGE WASHINGTON VANCE.

loss incurred through defalcation of George Sydney Jenkin, late bookkeeper at the City Ferries.

30th Cheques issued to all civic employees in full of May salaries.

In the interest of public safety approved the placing of a suitable public display sign at the Vancouver Ferry Terminal by the Forestry Department of the Provincial Government.
