Ltd. all actions, causes of action, claims and demands whatsoever that the Corporation may have under the provisions of Fidelity Bond Number 07452 and arising out of the defalcations of George Sydney Jenkin, be and is hereby approved and that the Commissioner and City Clerk signed same and attach the Corporate Seal thereto.

Advised by the Royal Bank of Canada that the rate of interest on Loans for the City has been reduced from 5-1/2 to 5-1/4 percent effective June 1, 1936. As of same date the rate of interest to be allowed on credit balances in Savings account is 1-1/2% on minimum monthly balances.

- 9<sup>th</sup> As a gesture of good-will towards the Jubilee Celebration Committee, granted permission to the Lynn Valley Veterans' Bank, when in uniform, to use the City ferries free of charge, for the purpose of playing the passengers on and off the boats during the months of July and August.
- Held enquiry in the Council Chamber for the purpose of determining whether the buildings or any of them, situated on Lots 49 & 50 in Block 166, D.L. 274 are a nuisance or dangerous to public safety.

Ordered that immediate steps be taken to serve the necessary orders on all of those interested that the buildings in question be and are hereby declared a menace to public safety, and the owners shall proceed on or before 60 days after issuance of notice to tear the building down, after which date the Corporation, if the owners have not already done so, will proceed to have the building torn down at the Owners' expense.
