- 1st Received letter from Interlake Tissue Mills Co. Ltd., stating that it is not their general practise to sell their containers.
- 2nd Tenders for Paper Towels, toilet tissue, etc., were considered and the tender of the North Shore Press in the amount of \$514.00 was accepted, on the understanding that the necessary replacement in fixtures will be done by them, the said fixtures when installed to become the outright property of the City.

At 10.30 a.m. Mr. Read, representing the Engineer's Association and representatives of the officers of the Ferries, met the Commissioner and discussed increase in salaries. The matter was finally left to the discretion of the Commissioner.
