- 2nd The following By-laws were reconsidered and finally adopted by the Commissioner, signed by him and the City Clerk and sealed with the Corporate Seal:-  
 "The City of North Vancouver Percentage Additions By-law, 1939."  
 "City of North Vancouver Tax Levy By-law 1939."  
 "City of North Vancouver Sinking Fund Reduction Levy By-law, 1939"  
 Copies of the above By-laws were forwarded to Victoria for the approval of the Lieutenant-Governor in Council.
- 2 Statement of cash receipts for the month of February, was received and filed.
- 3 Statement of Ferry Receipts for the month of February was received and filed.
- 3rd Authorized that Dalby E. Kendall of 1337 Mahon Avenue be notified to vacate the premises situated on Lot 11, Block 64, D. L. 271-548 at the above address, on or before the 30th day of April 1939.
- 5 Report of the School Inspector for the month of February was received and filed.
- 4th Took delivery by mail this morning from Pemberton & Son Vancouver Limited of \$500.00 City of North Vancouver 5 $\frac{1}{2}$ % bond due August 1st 1944 at the price of \$28.00 flat.  
 Authorized that cheque be issued in settlement of this purchase.
- 8th Police report for the month of February was received and filed.
- 18 Tenders were received for supplying 3600 feet of 10 inch Wire Wound Wood Stave pipe from -  
 - Paine Hardware Limited \$1.10 per lineal foot  
 Canadian Wood Pipe & Tanks \$1.11 per foot.  
 Authorized that the tender of Paine Hardware Limited, at the price of \$1.10 per foot be accepted. -
- 9th A delegation of Unemployed men who work for their relief, interviewed the Commissioner this morning requesting that the scale of their allowance be increased.  
 Authorized that the matter be taken up with the Minister of Labour.
- 10 The Agreement re chicken houses which was executed by the City and Miss Madge Hodgson and registered in the Land Registry Office, was withdrawn from the L. R. O. as Miss Hodgson is only Executrix of the property mentioned and could not register the agreement without a lot of legal formality. The agreement is in effect but not registered.
- 10th Mr. E. H. Bridgman, Deputy Minister of Municipal Affairs, met the Commissioner this morning and discussed Municipal Affairs.
- 12 Received copy of Report on Finances prepared by Mr. W. F. McIlroy. Filed.
- 13 The Commissioner considered the installation of a private branch exchange switchboard for the City Hall, costs being submitted by the B. C. Telephone Company.  
 After going into the matter thoroughly it was decided not to make any change this year.
- 14 Forwarded to the Administrator Unemployment Relief, Form R. A. 12-B (Revised) covering Relief disbursed for the month of February.

- Received certified copy of Order-in-Council No. 269 approving "City of North Vancouver Percentage Additions By-law 1939" numbered 1512

- Received the approval of the Deputy Inspector of Municipalities of British Columbia to the "City of North Vancouver Sinking Fund Reduction Levy By-law 1939."
- Authorized that the Canadian Merchant Service Guild Inc. and the National Association of Marine Engineers be notified that no Agreements will be entered into this year until such time as a policy has been considered and adopted with regard to the operation of the Ferries, under the present conditions.
- 14th Authorized the purchase for sinking fund purposes of \$500.00 City of North Vancouver 5 $\frac{1}{2}$ % bond due August 1st 1944 at the price of \$28.00 flat, from Pemberton & Son Vancouver Limited.
- Tenders for the Annual Overhaul of No. 4 Ferry were duly opened.  
There being only one tender received it was authorized that the tender of the Burrard Dry Dock Co. Ltd., in the amount of \$685.00 be and it is hereby accepted, work to be completed in three working days.
- Authorized that the usual letter be sent to the Harbour Navigation Company with regard to the Hire of the "Harbour Princess" on March 20th, to take the place of No. 4 Ferry during annual overhaul.
- 15th Took delivery by mail from Pemberton & Son of \$500.00 City of North Vancouver 5 $\frac{1}{2}$ % bond due August 1st 1944 at the price of \$28.00 flat.
- Authorized that a preliminary meeting be called for Monday, March 20th in the Ferry Room to make arrangements re the King's Visit, West Vancouver representatives also to attend.
- 16th Forwarded to the General Superintendent, Employment Service of Canada, accounts for relief disbursed by the City of North Vancouver for the month of February.
- Forwarded to the Director of Medical Services statement of Heads of Families and Single cases on Relief for the month of February.
- Forwarded to the Administrator of Unemployment Relief, declaration of expenditure re supplying clothing and boots to eligible indigent persons for the month of February.
- Tenders were received for the supply of one 2 $\frac{1}{2}$  to 3 ton truck, and one light delivery, and opened by the Commissioner.  
Authorized that these tenders be referred to the Superintendent of Works for tabulation and report.
- "The City of North Vancouver Tax Lands Sale By-law 1939, No. 3" was introduced and given three readings.

- 20th Ferry No. 4 went off the run for Annual overhaul, the "Harbour Princess" taking her place.
- Authorized the approval of Drawing No. A.13116 of the B.C. Telephone Company approving the location of poles on 6th Street between Sutherland and Hendry Avenues.
- At 8 p.m. attended Preliminary meeting to make preparations for the visit of The King and Queen.
- 21st Executed Agreement between Stuart Cameron & Co. Ltd., and the City authorizing the acceptance of three-twelfths of the taxes on Lots 1, 2 & 3, Block 175, D. L. 274 and land covered by water fronting this property, as the said Stuart Cameron Co. Ltd., will cease to occupy the said lands on or before March 31st 1939.
- Authorized the purchase for sinking fund purposes of £700. City of North Vancouver 5% bonds due 1963, at the price of \$27.00 flat from A. E. Ames & Company.
- 22nd The Superintendent of Works reported on tenders received for truck and Light Delivery.
- Authorized that the tender of Buster's Super Service Ltd., for supplying three ton 1939 Ford Truck at the price of \$2125.50 and Light Delivery at the price of \$528.34 be and it is hereby accepted.
- 23rd Granted permission to the Boy Scouts Association to use Mahon Park on Saturday, June 3rd.
- 25th Delivery was taken from A. E. Ames & Company of £700. City of North Vancouver 5% debentures, due July 1st 1963 at the price of \$27.00 flat.

- The Ferry Superintendent reported trouble on No. 3 Ferry when a stud in the follower ring of one of the pistons broke at 9.15 p.m. No. 3 was taken off the run at 10.25 p.m. and No. 4 Ferry carried on for the remainder of the night's run.
- Repairs were effected during the night and usual schedule maintained on the morning of the 30th.

29th Resolved that commission to be paid on sales of improved property be 5% up to \$10,000.00 and 2 $\frac{1}{2}$ % from \$10,001.00 up, and that the Secretary of the Real Estate Association be advised accordingly.

Atterded meeting in the Horticultural Hall at 8 p.m. with regard to making arrangements for the King's intended visit to the North Shore on May 29th.
