As a mark of respect to the late Governor-General of Canada, the Commissioner declared the Civic offices closed for this afternoon.

15th

Received Certified copy of Order-in-Council No. 151 dated 13th February 1940 approving "City of North Vancouver Tax Lands Sale and Exchange By-law 1940, No. 2."

Authorized the approval of B. C. Electric Railway Company Drawing No. K-8800/2523 showing proposed pole line construction on 27th Street west of Chesterfield Avenue, North Vancouver City.

Authorized that tenders be called for printing tax notices, same to be received by noon on February 20th.

17th

"The City of North Vancouver Tax Lands Sale By-law 1940, No. 2" was introduced and given three readings.

Forwarded to the Administrator of Unemployment Relief, Declaration of expenditure re supplying clothing and boots to eligible indigent persons for the month of January.

Forwarded to the Director of Medical Services statements of Heads of Families, Single Cases and Unemployables on Relief for the month of January.

Letter was received from the District of West Vancouver regarding the float at Vancouver Ferry Terminal, which they state is waterlogged. Authorized that the District of West Vancouver be advised that logs for repair of the said float are on order and repairs will be effected as soon as the logs are received.

19th

Whereas certain arrangements were made by and between the Vancouver Harbour Commissioners and the Corporation of the City of North Vancouver, relative to the construction and operation of a Terminal Railway running through the City of North Vancouver to connect with the Pacific Great Eastern Railway in that City and to the acquisition by the Vancouver Harbour Commissioners of certain streets, street-ends and lots owned by the City.

AND WHEREAS arising out of the determination of the true intent and meaning of these arrangements certain differences existed between the parties.

AND WHEREAS these differences were adjusted and an Agreement in writing prepared setting out the adjustments arrived at: which Agreement is dated the day of 1936.

AND WHEREAS the said Agreement has been signed on behalf of the Corporation of the City of North Vandouver but before being signed by the National Harbours Board (the successors to the said Vancouver Harbour Commissioners) it is desired that the obligation with reference to the maintenance and upkeep of the storm sewers and

stream outlets as expressed in Paragraph 11 of the said Agreement should be clarified.

AND WHEREAS on the 26th day of May 1936 George Washington Vance was appointed Commissioner of the Corporation of the City of North Vancouver under Part XXIII of the "Municipal Act," being Chapter 199 of the Revised Statutes of British Columbia 1936 and Amending Acts and under the said Act all the rights, powers and authority vested in or exercisable by inter alia the Mayor and the Council of the Municipality of the City of North Vancouver are vested in the said Commissioner.

THEREFORE the said Commissioner, in exercise of all the powers him thereunto enabling doth hereby resolve and agree as follows:(1) That the true interpretation, meaning and intent of the said Paragraph II contained in the said Agreement shall be and is that the Corporation of the City of North Vancouver upon execution of this Agreement will in all time hereafter and at its own cost and expense maintain and keep in good condition and repair the storm sewers and stream outlets in so far as they now exist or may hereafter exist in, upon, over or under the road or street known as the Low Level Road, described in Paragraph 9 of the said Agreement, in its entire width and length, the National Harbours Board, the other party to the said Agreement at all time and at its own cost and expense maintaining and keeping in good condition and repair the storm sewers and stream outlets in, upon, over and under the property owned by it exclusive of the said road or street.

(2) That this Resolution shall not be capable of being revoked at any time or to any extent and shall be and remain a covenant by the Corporation of the City of North Vancouver and as such enforceable against it in regard to the maintenance and upkeep of the said storm sewers and stream outlets in, upon, over and under the said Low Level Road in all time to come.

(3) That as evidence of the coverant herein contained a true copy of this Resolution certified by the Clerk of the City of North Vencouver and sealed with its Corporate Seal shall be made and forwarded to the said National Harbours Board at the City of Vancouver along with a true copy, certified in like manner, of the appointment of said George Washington Vance as Commissioner of the City of North Vancouver.
