- 1st Dominion Day - Public Holiday .
- 2nd Authorized the appointment of Miss Marian A. Sproule to the staff of the Senior High School at a salary of \$1400.00 per school year.
- 3 Report of the School Inspector for the Month of June was received and filed.
- 4 "The City of North Vancouver Land Sales By-law 1940, No. 3" was introduced and given three readings.
- 4th Report of Ferry Receipts for the month of June was received and filed.
- 5 Received the resignation of L. A. Matheson, Principal of Ridgeway School.
- 6 Authorized that the above resignation be accepted.
- 7 Received claim for damages from E. Woodard, 246 West 16th Street for the loss of eleven chickens killed by dogs.
- 8 Authorized that a cheque be issued to E. Woodard for \$11.00 in full settlement of his claim re loss of eleven chickens, on the distinct understanding that his premises will be put in such shape that dogs cannot gain entrance again in the same manner.
- 9 "The City of North Vancouver Land Sales By-law 1940, No. 4" was introduced and given three readings.
- 10 Authorized that A. E. Crickmay be notified that it is not the policy of the City to construct private crossings and it does not hold itself responsible for any accident which might occur at a private crossing.

- 10 Statement of cash receipts for the first 6 months of 1940 was received and filed, and copies forwarded to the Deputy Minister of Municipal Affairs.

- 15th Authorized that John McPherson be granted an additional \$10.00 per month effective August 1st 1940 as a bonus for the extra work and responsibility undertaken by him on account of the absence on War Service of the Ferry Superintendent.
- Authorized that E. Pare be granted an additional \$10.00 per month, effective August 1st 1940 as a bonus for the extra work and responsibility undertaken by him on account of the absence on War Service of the Ferry Superintendent.
- 16th Forwarded to the General Superintendent, Employment Service of Canada, accounts for Relief disbursed by the City for the month of June.
- Forwarded to the Director of Medical Services, statements of Heads of Families, Single cases, and Unemployables on Relief for the month of June.
- Forwarded to the Administrator of Unemployment Relief, declaration of expenditure re supplying clothing and boots to eligible indigent persons for the month of June.
- Authorized that those parties who petitioned the Commissioner to have lane in Block 78, D.L. 550, opened up, be advised that after careful consideration it has been decided not to open this lane at the present time.
- Police report for the month of June was received and filed.
- 17th Authorized that the Army & Navy Veterans in Canada be granted permission to hold a tag day in the City of North Vancouver on Saturday, August 3rd in aid of their Ambulance Fund.
- 18th Received certified copy of Order-in-Council No. 860 dated July 16th 1940 approving "The City of North Vancouver Land Sales By-law 1940, No. 4".
- Authorized that leave of absence for the duration of the war, or a shorter period, be granted to Alex. Young, truck driver, as per ruling of the Commissioner contained in resolution of May 23rd 1940.
- 19th Received letter from the Kinsmen Club of North Vancouver advising that the Children's Playground which they are building is near completion and they expect will be ready for use about August 15th, and requesting certain improvements to surrounding property.
- Authorized that the Kinsmen Club be advised that the City will accept the playground when completed and that the improvements to surrounding property be carried out by the Board of Works.
- Authorized that S.S. Penny be advised that the City will grant the Horticultural Hall to the Government for National Registration on the dates to be decided upon, free of charge.
- Received letter from the Vancouver Exhibition Association requesting the City to enter a float in the Parade of Progress on August 26th.
- Authorized that the Board of Trade and Jr. Board of Trade be written to, requesting them to consider the proposal.
- 22nd Authorized the approval of Drawing No. K-8800/2601 of the B.C. Electric Rly. Co., showing proposed pole line construction on 16th Street East of Moody Avenue (offset 12' 6").
- 23rd Authorized the appointment of Donald Tysse to the High School staff to take the place of E. R. Chamberlain, transferred to Ridgeway School, at a commencing salary of \$1400.00 per school year.
- 24th "The City of North Vancouver Tax Lands Sale By-law 1940, No. 9" was introduced and given three readings.

25th

Authorized the approval of Drawings No. K- 8300/2602 and 2603 of the B. C. Electric Rly. Co., showing proposed pole line construction on 25th Street East of Mahon Avenue, and on Eastern Avenue, South of 29th Street.

26th

"The City of North Vancouver Tax Lands Sale By-law 1940, No. 9" was re-considered and finally adopted by the Commissioner, signed by him and the City Clerk and sealed with the Corporate Seal.

Certified copies were forwarded to Victoria for the Approval of the Lieut. Governor in Council.

Authorized that owing to the continued dry spell, sprinkling regulations be put into effect in the City as from this date, sprinkling to be allowed only between 6 & 8 A.M. and 7 & 9 P.M. daily and that notice be inserted in the local papers.

A meeting was held in the Council Chamber, City Hall, on July 26th at 8 P.M. of representatives from various sections of Vancouver North riding in connection with the registration of man power to be held in August.

Major S. S. Penny detailed steps already taken towards this registration and Commissioner Vance was asked to arrange for a Committee in connection with the District covered by the City and District of North Vancouver.

27th

Authorized that Alex. Miller be appointed temporary truck driver for the City, effective July 15th 1940 at the rate of \$4.00 per day.

29th

Authorized that owing to a necessary reduction in staff in the Relief Department, W. F. Binns be notified that his services be dispensed with on 31st August 1940.

30th

Authorized that W. N. Keeling is hereby appointed to the permanent staff of the Treasurer's Department.

Authorized that owing to a necessary reduction in the staff of the Relief Department, C. G. Limpert be notified that his services will be dispensed with on 31st August 1940.

31st

Authorized that application be made to the National Harbours Board requesting the rate of interest payable under Agreement of 12th July 1933 (Re Second Narrows Bridge) be reduced from 5% to 3½%, this being the rate now payable to the Royal Bank, and that James Sinclair, M.P., be requested to lend any aid in his power towards this end.

Received report from the Supt, of Works, that the fill at the foot of Chesterfield Avenue has been completed and fenced satisfactorily with the exception of sewer outfall pipe is not sufficiently covered, and suggesting that reflector lights be installed on their fence as a warning that the road terminates at this point.

Authorized that copy of the above report be sent to the North Vancouver Land & Improvement Co.

Received letter from the Commissioner of B. C. Police, Victoria, that the cost of policing the City will have to be increased, as the City was policed at a deficit last year.

Authorized that Mr. Parsons be requested to interview Commissioner Vance the next time he is in Vancouver.

Received resignation of Miss McCarthy as employee of Treasurer's Department, to take effect 15th September 1940.

Resolved that Miss Stuart be transferred to Treasurer's Department from Relief Office at a salary of \$70.00 per month and that Mr. Valentine be authorized to fill the vacancy in the Relief Office at a salary of \$65.00 per month.
