The Superintendent reported no claim has been filed.
 - Authorized the approval of B. C. Telephone Company Drawing No. E. 14422 covering proposed poles and anchors on Ridgeway Avenue between 11th and 3rd Streets, also in various locations east and west of Ridgeway Avenue between St. George's Avenue and Queensbury Avenue.
 - Authorized that the local Doctors be written to regarding having the Ferry Captains and Engineers medically examined at certain periods of the year, on account of their responsibility on the ferry system and suggesting a fee of \$3.00 for each examination.

of the Municipal Act that the amount of assessment of pole lines, cables, and wires of any telephone, telegraph, electric light or power company shall be, in the case of Municipalities with a population of less than ten thousand, One Hundred and Twenty-five Dollars (\$125.00) per mile.
