MINUTES OF MEETING OF THE ACTING COMMISSIONER EXERCISING THE POWERS OF A COUNCIL, HELD IN THE CITY COUNCIL CHAMBER, 15th OF JULY 1943, at 3 P.M.

Acting-Commissioner G. H. Morden was in the chair and before proceeding with the business addressed the meeting as follows:

"As this is the first Council meeting that has been held in the City of North Vancouver for about ten years I think perhaps it is just as well for the Acting-Commissioner to present the matter as he sees it.

The portion of the "Municipal Act" covering the appointment of a Municipal Commissioner, Section 507 reads as follows:-

(Quoted Section 507)

Nowmy interpretation of this section is that the Council has not been changed, only the membership of the Council has been changed from seven in number to one member but the Council has to function as before a Commissioner was appointed. Therefore, we have called this first meeting of the Council. We propose to meet once a month on the third Thursday at 3 o'clock in the afternoon. If during that month certain things arise in Municipal affairs that require more prompt attention we propose to give that attention through special meetings of the Council to be regularly called but the minutes of each special meeting will be kept and approved on the following open meeting."

MINUTES kept by the City Clerk from the 1st of July to date were read and adopted.

CORRESPONDENCE was submitted and dealt with as follows:

Letter from the Loyal Protestant Home for Children, requesting permission to hold a tag day on Saturday, October 2nd.

Resolved that this permission be granted.

Letter from the B. C. Electric Railway Company Ltd., stating that the McKay Creek bridge has been condemned and requesting permission to run busses over route shown on attached plan, and offering to permit the City authorities to tear down the bridge for firewood.

In this connection, report from the Superintendent of Works, recommending that the City did not undertake the demolishing of the bridge was read and adopted, the remainder of the letter being referred to the Committee of the Whole.

<u>PETITIONS</u>: Petition from barbers in the City requesting repeal of the present Early Closing By-law was submitted.

Resolved that the petition of the Barbers to repeal By-law No. 1311, "City of North Vancouver Barber and Hairdressing Shops Early Closing By-law, 1931" in so far as it affects barber shops, be granted and the Solicitor requested to prepare the necessary repeal by-law.

REPORTS:

The Clerk reported progress under the Refunding Act and submitted certificate signed by the Clerk, Treasurer and the Government representative that the Securities in Sinking Fund had been cancelled.

Resolved that the Treasurer is hereby authorized and directed to burn and destroy the bonds and debentures

listed in the Certificate of Cancellation dated the 8th day of July 1943 and signed by the Treasurer of the City and the Clerk of the City and B. C. Bracewell, representative of the Department of Municipal Affairs.

The Assessor reported on land sales for the first six months of this year showing comparison with the corresponding period for 1942. He also submitted Sales List for the month of June totalling \$1,775.00.
