NEW BUSINESS:

The Commissioner made the following statement:
"At the first meeting I made certain remarks as to the procedure indicated in my opinion, under Clause 507, of the Municipal Act re appointment of a Commissioner.
Since then I asked the City Solicitor to give me his opinion in writing. I have received same and was wrong in part."

Resolved that the Solicitor's opinion be spread on the Minutes:

"In the first place, it is to be observed that the Commissioner is not made the successor in office of the council which is abolished by the enactment that the members of the Council shall be deemed retired from office. In contrast, it is also noted, and this is important, that a Commissioner, by Section 507, is expressly made to be the successor in office of the Board of School Trustees and to be the Board of School Trustees. If it had been intended that a Commissioner should be the successor in office of the members of the council and that he be the council, a provision to that effect would have been made as is made in the case of the School Trustees. He would then be governed by the same procedure as a council. There is no doubt that meetings of a Commissioner as a School Board must be governed by the same procedure as meetings of the School Board, duly elected, because a Commissioner, is by statute, made to be the School Board; but he is not made to be the Council. The Statute confers upon a Commissioner all the rights, powers and authority of the Council, or, in other words, the jurisdiction is taken away from the Council and is given to another governing body, namely, a Commissioner. There is no provision in the Act setting out the procedure governing a Commissioner in regard to his administration of affairs. This omission from the statutes was made purposely. In fact the Statute expressly provides that the methods of procedure governing a Commissioner's administration may be provided for and made by the Lieutenant-Governor in Council in the form of regulations.

It would not be proper for me to express any opinion upon whether or not, as a matter of policy, a Commissioner should conduct the business of the City at times and places open to the public, as that is a matter for the Commissioner to decide, subject to any regulations that may be made by the Lieutenant-Governor in Council governing the methods of procedure pursuant to Section 513."
