Authorized that the above request be granted and that J. Rodger Burnes be requested to make the survey.
- 5th 7 Tender was received from the Vancouver Pile Driving and Contracting Company Limited in the amount of \$1266.00 for supplying creosoted material and labour to construct inclined Pontoon Ways at the foot of Chesterfield Avenue.

Also tender of \$240.00 for supplying creosoted piling and necessary wrapping wire and construct 2 three-pile dolphins and two single piles to carry boom logs to protect above ways.

Authorized that the above tenders be accepted, work to be done to

the satisfaction of the Superintendent of Works.

- 6th /2 Authorized that the Circulation Manager, Vancouver Daily Province, be notified that they will have to remove Carrier Substation from Lot 10, Block 6, D. L. 265, to some other property.
- City offices closed for Easter Holidays.
 - 11th & Authorized that overtime be paid to City outside employees as follows:-

Day Labourers

That all day labourers be paid for overtime work performed at the rate of time and one-half for such overtime performed in excess of eight hours in any working day. Said working day shall constitute any continuous working period of eight hours between 8 a.m. on Monday and 12. o'clock noon on Saturday. The rate for overtime from 12 o'clock noon on Saturday till 12 midnight on said day and from midnight Sunday to 8 a.m. Monday, shall be at time and one-half and any time worked on Sunday or Statutory holidays, shall be at the rate of double time. Where it is necessary to engage in work demanding a special shift, the overtime clause shall come into effect after eight hours work - excepting Sundays and Statutory holidays when the double time clause shall be effective.

Salaried Employees:

All salaried employees shall be paid the regular rates for overtime if called out between Saturday noon and 8 a.m. Monday or Statutory holidays - excepting truck drivers who shall be entitled to overtime between 4.30 p.m. Saturdays and 8 a.m. Monday and Statutory holidays. - 13th Authorized that letter be sent to the Secretary of the Civic Employees Association, setting out the Commissioner's decision with regard to the proposed working Agreement submitted by the Association.
 - F Report of School Enrolment and attendance for the month of March was received and filed.
 - 9 Authorized that R. R. Harris, Veteran Motor Cycle Delivery, be advised that a certain area at the Ferry Wharf is set aside for a taxi stand, but as it is fully occupied, permission cannot be granted to park on the wharf.
 - Received permission from the Rentals Appraiser to increase the rental for privileges enjoyed by the District of West Vancouver at the Ferry terminal, Vancouver, to \$225.00 per month. The increase of \$25.00 per month is allowed on account of additional waiting room accommodation provided by the City of North Vancouver.

 - Authorized that Mr. E. H. Valentine attend a meeting in the City Hall, Vancouver, on behalf of Commissioner Vance, re proposed public ownership of the B. C. Electric system.

 - * The Acting Ferry Superintendent reported that it is impossible to get sweaters for the Ferry Crew in Vancouver. He stated that Barradell's suggested that an order be placed with an Eastern firm which makes sweaters for the C. P. R., C. N. R. etc. No price can be quoted.

Authorized that as sweaters cannot be obtained here that Barradell's be requested to obtain them as suggested, the Ferry Superintendent to supply measurements.

- 20th Received petition from Owen F. Croft and 7 others protesting against permitting the sale of tax sale lots in good residential areas without any restriction against unsightly buildings being erected.

 Referred to the Town Planning Commission.
 - 6 Tender was received from Barradell's for supplying Navy serge pants for Ferry crew members at a price of \$7.50 per pair.

 Authorized that the above tender be accepted, Mr. McPherson to furnish necessary measurements.

- 27th Authorized that the Commissioner and City Clerk execute declaration that the mortgage on Lot 13, Block 14, D. L. 550 in the name of George A. H. Baxter is fully paid to the City of North Vancouver and the same is now discharged.
 - a Received copy of Order-in-Council P.C. 9919 whereby all employers are required to examine documents held by male employees, in order to establish that no employees have failed to comply with National Selective Service Mobilization Regulations.

Mr. R. C. Gibbs was appointed to check up on this matter. Upon check being completed the Registrar of National Selective Service Mobilization Section was notified that two men could not produce papers, although they claim to have complied with regulations some time ago. The men affected are Joseph Hanlon, swamper, City of North Vancouver and Harold G. Loucks, City School Board.

A Received verbal proposition from Messrs. Joy and Crowe to build a number of houses on a lot at the corner of 15th Street and St. George's Avenue.

Referred to the Town Planning Commission for an opinion.

- Authorized that Agreement be signed by the Commissioner as Chairman and Captain G. R. Bates as Controller, whereby the Dominion Government will build and deliver to the Civil Defence Committee of the City and District of North Vancouver a Fire Barge equipped with three Bickle Seagrave 500 gallon per minute portable pumps.

 Ownership of Barge and equipment will remain in His Majesty but the City will man and maintain same, and be responsible for same while it is in the possession of the Committee.
- 28th Authorized that cheque for \$6,100.00, the amount agreed to be paid by the School Board of the City of North Vancouver towards the cost of erecting a four roomed school on Block 100, D. L. 550 (Ridgeway School addition), in accordance with Agreement at present being executed, be forwarded to Messrs. McCarter & Nairne.
 - 6 Received certified copy of Order-in-Council No. 617 dated 25th April 1944 approving "The City of North Vancouver Tax Lands Sale By-law 1944, No. 3."
 - Received Certified copy of Order-in-Council No. 605 dated April 25th 1944 setting Wednesday, June 14th 1944 as the date for taking the Referendum authorized by Section 35 of the "City of North Vancouver Debt Refunding Act," which reads as follows:-
 - "THAT by Order of the Lieutenant-Governor in Council No. 628, approved on the twenty-sixth day of May, 1936, George Washington Vance was appointed Commissioner of The Corporation of the City of North Vancouver, pursuant to the provisions of Part XXIII of the "Municipal Act."

AND THAT by Section 35 of the "City of North Vancouver Debt Refunding Act," being Chapter 47 of the Statutes of British Columbia,1943, provision is made that in the year 1944 and before exercising the power contained in section 512 of the "Municipal Act," the Lieutenant-Governor in Council shall by regulations provide for the submission to the electors of the City, entitled to vote on any bylaw for raising money upon the credit of the City, of a referendum on the question "Are you in favour of the powers and authority of the Commissioner being continued for the years 1945 and 1946?"

AND THAT the Commissioner after due consideration has recommended that Wednesday, June 14th 1944, be the date set for the taking of the referendum:

AND TO RECOMMEND THAT pursuant to Section 35 of the "City of North Vancouver Debt Refunding Act" the following regulations be made:

1. The referendum aforesaid shall be held on Wednesday the fourteenth day of June, 1944, between the hours of eight o'clock

in the forenoon and eight o'clock in the afternoon.

- 2. Don.G. Tate, Esquire, City Clerk of North Vancouver, British Columbia, shall be the Returning Officer for taking the votes of the electors in that behalf, and, except as herein is otherwise provided, he shall so far as possible conduct the proceedings as nearly as may be as at a municipal election.
- 3. The Commissioner shall in the month of May 1944 appoint by By-law or resolution:-
 - (a) The place or places at which polls will be opened in the municipality:
 - (b) The Deputy Returning Officers who will preside at the respective polling places.
- 4. The Commissioner shall before the referendum date furnish the Returning Officer and each Deputy Returning Officer with a copy of the list of voters, a ballot box or boxes and the necessary ballots for use at the respective polling places, and shall otherwise arrange for obtaining the opinion or vote of the electors aforesaid:
- 5. The list of voters shall comprise those persons and corporations entitled to vote on any by-law for raising money upon the credit of the City and the Commissioner shall arrange for sufficient copies of the current annual list of voters to be revised so as to exclude therefrom the names of all persons and corporations who are not entitled to vote on money by-laws pursuant to subsection (2) of section 180 of the "Municipal Act" and to include therein or add as supplementary thereto the names of all persons and corporations who since the thirty-first day of October last past and prior to the fourteenth day of May 1944, have become owners of land within the municipality.
- 6. The referendum shall be taken by ballot on the question "Are you in favour of the powers and authority of the Commissioner being continued for the years 1945 and 1946?" Yes or No.
- 7. Subject to the foregoing the provisions of the "Municipal Elections Act" shall mutatis mutandis apply to the referendum authorized as aforesaid.

AND THAT a copy of this Minute, if approved, be forwarded to both G. W. Vance, Commissioner, and Don. G. Tate, City Clerk, at North Vancouver, B.C.
