- Resolved that School children residing on Sutherland & Hendry Avenues and Streets west of Hendry in the District, attend Ridgeway School, the District School Board to pay the usual fee for each pupil attending the City School.
- 25th Application for increase in salary was received from Mrs. J.L. Green in the Engineering Department.

Authorized that Mrs. Green be advised that her request is being laid over for consideration next year.

- Authorized the approval of Drawing No. K-8800/3474 of the B.C. * Electric Railway Company, showing proposed poles on 16th Street East of St. Andrew's Avenue.
