- 3. That the Board of School Trustees shall have and may exercise all the powers and authority vested in the Board of School

Trustees of a municipal school district prior to the appointment of the Commissioner.

AND THAT the powers and authority vested in the Commissioner pursuant to Part XXIII of said Act, be revoked:

AND THAT this Order take effect on the First day of January, 1945;

AND THAT this Order be published in one issue of the Gazette:

AND THAT a certified copy of this Minute, if approved, be transmitted to George H. Morden, Commissioner, and to D. G. Tate, Clerk, of the said Corporation, at North Vancouver, B.C.
