Said changes to be retroactive to January 1st 1945.

RECOMMEND that Whereas rates established by the Salary Commission are acceptable to the Employees Association, we recommend that the schedule as set forth in the report of the Commission for outside staff, become effective from the first of January 1945, plus the Cost-of-living Bonus of \$20.00 per month and that this Cost of Living Bonus be now incorporated in the hourly rates and monthly rates.
