Motor Transportation Limited for a Bus Loading Zone at the North West corner of Lonsdale and Esplanade and recommended that his Committee meet with Mr. Neil, the General Manager of the Company, with a view to arranging a suitable location for such a Zone.

AND WHEREAS the late Commissioner of the City signed an Agreement dated the Eighteenth day of February 1943 whereby he agreed on behalf of the City to install a modern chlorination system for the duration of the war,

AND WHEREAS in the discussions which insued in public meetings and in the press it was announced that this action was a war measure in view of a possibility of contamination of the water

by the Japanese, AND WHEREAS it is apparent that any danger from this source is

practically non-existent,
THEREBY BE IT RESOLVED that this Council request the Government to remove the plant from our water supply and further that this Council advise the Government that tests of the water supply have shown it to be pure and that public opinion is strongly against a continuation of chlorination and that a copy of this resolution be forwarded to the Prime Minister, to the Department of National Health, Ottawa, and to the Premier of the Province.

Voting against: Aldermen Gostick, Humphreys, Millar & Stewart. The motion was declared lost.
