. The meeting was advertised as required by Statute.

Before taking up the business of the evening, Mayor Loutet called attention of the Aldermen to an editorial appearing in a recent issue of the Vancouver Daily Province, which in  $_{\gamma}$  general terms stated that the City was attempting to evade its responsibility re social assistance to War Workers who have

moved here since the outbreak of War. Mayor Loutet stated that the facts in the editorial were not

true but asked that the matter be laid over until he has had an interview with Mr. Lundy of the Social Assistance Branch of the Provincial Government.

Moved by Alderman Walker, seconded by Alderman Gostick that the Minutes of the Special Meeting of the Council, held on July 9th 1945 be taken as read and adopted. Carried.

CORRESPONDENCE From the Clerk of the Township of Richmond, advising that his Council had passed a resolution giving full support to the City \* of North Vancouver's objection to being made responsible for

- Social Assistance to Wartime Housing tenants. Moved by Alderman Gostick, seconded by Alderman Walker that this letter be received and filed. Carried.
- From J. P. Sweeney, 850-4th Street East, requesting Street 5 lamp at the corner of 4th and Hendry Ave. This request was referred to the Fire and Light Committee.

From the B. C. Electric Railway Company Limited, North Vancou-ver, advising that street light breakages are still above average in the City of North Vancouver. Ordered received and filed.

From the North Vancouver Civic Employees Association thanking A the Council for their consideration and co-operation in arranging for their Annual picnic on August 15th next. Ordered received and filed.

From Mr. E. F. Latta, on behalf of the North Vancouver Pentecostal Tabernacle, applying for permission to conduct a street % meeting at the corner of 15th and Lonsdale Avenue, every Satur-day or Sunday evening between the hours of 7.00 and 8.00 o'clock. Moved by Alderman Gostick, seconded by Alderman Millar that the above request be not granted. Carried.

From Rose E. Tennant, requesting a gravel path from 19th to 20th Street, in the vicinity of her home at 862 Cumberland Crescent, and advising that she would provide the labour if the 4. City would provide the material for same.

Moved by Alderman Millar, seconded by Alderman Gostick that the work requested will be done as soon as men are available, it not being feasible for Mrs. Tennant to supply the necessary labour, as trucks etc. would be necessary to carry out this work. Carried.

From Mr. E. W. Griffith, Assistant Deputy Provincial Secretary, advising that the issuance of Social Assistance should not be , held up Arbitrarily until a discussion has been held concerning the responsibility of caring for War Workers residing in the City.

Moved by Alderman Walker, seconded by Alderman Millar that this letter from Mr. Griffith be laid over until Mayor Loutet

# FERRY COMMITTEE

Alderman Millar reported that negotiations are proceeding with the Canadian Seamen's Union with a view to completing the new agreement covering the wages and working conditions of the Ticket Sellers, Collectors, Watchmen, Cleaners and Labourers employed by the City Ferries.

RECOMMEND that the North Van Ship Repairs Limited be given perission to dig a disposal pit as requested and permission to burn refuse oil in it for the period of the next two months; i.e. August and September; with the understanding that all possible steps will be taken to find a more satisfactory solution by that time.

RECOMMEND that the City Clerk write the National Harbours Board advising them that some other method be employed to dispose of 'the refuse oil from the local shipyards, as the present method of burning same in the City dump is causing annoyance to residents of the North Shore.

Moved by Alderman Gostick, seconded by Alderman Walker that the above report of the Board of Works Committee be adopted. Carried. Mayor Loutet voting against the first recommendation.

# FIRE & LIGHT COMMITTEE

RECOMMEND that the proposed Agreement with the Fire Department as now amended, be forwarded to the firemen for the signature of their Bargaining representatives and if approved by the latter, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

RECOMMEND that the request of J. A. Harris for a street light on Eastern Avenue and 21st Street be not granted at the present time.

Moved by Alderman Gostick, seconded by Alderman Stewart that the above recommendations of the Fire and Light Committee be adopted. Carried.

# PARKS & HEALTH COMMITTEES

Alderman Walker reported that a suitable fire exit had now been installed at the Horticultural Hall as requested by the Fire Chief.

Alderman Walker also reported that he had attended the last meeting of the Metropolitan Health Committee, as the Council's representative and advised that several new appointments of Nurses had been made by the Health Committee to fill vacancies.

# MOTIONS

Moved by Alderman Millar, seconded by Alderman Stewart that the following resolution be forwarded to the Union of British Columbia Municipalities for endorsement by that body at their next annual meeting:-

That the "Residence and Responsibility Act" being Chapter 246 of the Revised Statutes of British Columbia, 1936, as amended, be further amended by adding to Section 4 thereof the following subsection:- "(4) Notwithstanding any of the provisions of this Act any person who at any time after the 3rd day of Septem-ber, 1939 has moved or shall move to a local area and has been or shall be employed in any establishment, classified pursuant to The National Selective Service Civilian Regulations as a 'designated establishment'; in such local area or any local area adjacent thereto, shall not be deemed to be a resident of such first mentioned local area until such person has resided continuously in such first mentioned local area for a period of one year after the date of the publication in the Canada Gazette of a proclamation of the Governor-General-in-Council that the hostilities in which His Majesty is presently engaged, have ceased." Carried.

Moved by Alderman Gostick, seconded by Alderman Walker that the Municipal Act be amended to provide authority for a "Municipality to insert Building restriction covenants in conveyances issued by the Municipality for Tax Sale lands. Carried.

# NEW BUSINESS

The Clerk submitted a request from Miss McCready, requesting an extra week's holiday because of her length of service with the City.

Moved by Alderman Millar, seconded by Alderman Walker that Miss McCready be granted one week's compassionate leave. On a show of hands the motion was declared lost.

## UNFINISHED BUSINESS

Alderman Humphreys reported that the Finance Committee had read the applications received by the Clerk for the position of Assessor and he recommended that Mr. J. D. Jellis be placed on probation in this position for a period of three months, at a starting salary of \$175.00 per month.

Moved by Alderman Stewart, seconded by Alderman Millar that Mr. J. D. Jellis be appointed Assessor for the City, for a probationary period of three months, at a starting salary of \$175.00 per month, his duties to commence as soon as possible.

In reply to an enquiry from Council members at a previous meeting the Clerk reported that Dr. W. G. Saunders was the appointed Medical mealth Officer for the City but that on October 15th 1942

Medical Health Officer for the City but that on October 15th 1942 whe had been granted indefinite leave of absence for the purpose of taking a position with Wartime Merchant Shipping and that subsequently Dr. Ella Evans had been appointed by the Commissioner on March 9th 1943 as Acting Medical Health Officer until the return of Dr. Saunders.

The Clerk submitted a proposed reply to the Vancouver Labour Council drafted by the Mayor in reply to their letter and resolution of June 28th pertaining to the release of City lots for housing. Moved by Alderman Stewart, seconded by Alderman Gostick that the reply as drafted by the Mayor be forwarded to the Secretary of the Vancouver Labour Council. Carried.

Moved by Alderman Humphreys, seconded by Alderman Gostick that the Clerk make reservations for 6 delegates to the Convention of the Union of B. C. Municipalities to be held at Qualicum Beach on September 6th and 7th 1945. Carried.

Mayor Loutet submitted a resolution in connection with the triennial assessment of land which he desired be forwarded to the U.B.C.M. & Convention.

Moved by Alderman Gostick, seconded by Alderman Millar that the following resolution be forwarded to the Union of B. C. Municipalities Convention for discussion:-

"That the "Municipal Act" be amended to provide that the Council may either by resolution or by By-law, provide for triennial assessment of land with provision for annual assessment changes in the case of new subdivisions or resubdivisions of existing lots, and with provision for the assessment of improvements annually." Carried. Alderman Humphreys voting against. Alderman Gostick reported that the Hospital Board had appointed Mr. F. E. Rickard, as the Board's auditor.

Superintendent Greenwood reported that the Labour situation was reaching a point where the Council would soon be faced with the necessity of replacing older men on the Board of Works staff with younger employees.

Alderman Humphreys reported that he had advised Co-Workers ~ Co-operative Committee that no proposal of the Committee to purchase Wartime Houses in the City would be acceptable to the Council if there was a possibility of the land on which the houses are built reverting to the Dominion Government in case of default by the purchasers.

At 11.20 p.m. it was moved by Alderman Walker, seconded by Alderman Gostick that the meeting adjourn.

Whereupon the meeting adjourned.
