#### REPORTS OF COMMITTEES

#### FINANCE COMMITTEE

RECOMMEND that the following resolutions be endorsed by the Council and forwarded to the Union of B.C. Municipalities for consideration at the next Convention of that Organization:-

THAT when any Act, other than the "Municipal Act", imposes a duty on any Municipality which involves expenditure of Municipal funds, that such Act or Acts, or any Amendment thereof, be submitted to the Union of B.C. Municipalities before approval of the Legislature.

THAT WHEREAS Section 224 of the "Municipal Act" provides that Crown Lands held under pre-emption or lease or agreed to be sold, granted or conveyed to, or are held or occupied by any person other than the Crown, shall with the improvements thereon be liable to assessment and taxation, from the date of such preemption or lease or agreement to sell, grant or convey, or while

so held or occupied; (Insert paragraph below)
AND WHEREAS it is desirable to provide that Crown lands shall become taxable at any time that they are sold, granted, conveyed, held or occupied by any person other than the Crown.

THEREFORE be it RESOLVED that the "Municipal Act" be amended

to provide that Crown lands shall become taxable and taxes shall be collectible at and from the time any such lands shall be sold, granted, conveyed, held or occupied for the period of such conveyance or occupation.

AND WHEREAS legal opinion is to the effect that such Crown lands may be placed on the Collector's Rolls as taxable, only if such lands were shown as taxable at the time of the compilation of the Assessment Roll:

THAT WHEREAS the Provincial Government appointed a Commission of Inquiry to inquire into the costs of Education in the Province.

AND WHEREAS the Inquiry recommended among other things, that the land owner should be relieved of a certain portion of the costs v of Education.

AND WHEREAS provision has been made for such relief commencing

with the year 1947, AND WHEREAS it is desirable that immediate relief be given the

owners of real estate in the year 1946. THEREFORE BE IT RESOLVED that the "Public Schools Act" as amended be further amended to provide that in Municipalities where the 1946 School Rate was fixed prior to the implementation of the Cameron Report, surplus monies remaining to the credit of the School Boards after all lawful school expenditures have been made, shall be transferred to the general funds of each such municipality for use for general purposes in the Municipality.

THAT WHEREAS the "City of North Vancouver Debt Refunding Act" provides that the City shall pay to the Board of Debt Retirement each year, a certain sum of money to be used by the Board for the purchase of refunding debentures, of for the redemption of refund-

ing debentures by call;
AND WHEREAS the said Act provides that, if default is made by the Trustees by failing to carry out their duries with respect to such purchase or redemption of debentures as aforesaid, final default

under the Act then occurs;

AND WHEREAS the said Board consists of three Trustees appointed by the City of North Vancouver, the Lieutenant-Governor-in-Council, and the Chief Justice of the Supreme Court respectively;

AND WHEREAS it is desirable in the event of default by the Trustees occurring as aforesaid, that the City Council be authorized to fulfill the obligation of the Trustees and thus obviate final default; THEREFORE BE IT RESOLVED THAT the "City of North Vancouver Debt Refunding Act." be amended to provide that the Council of the Corporation of the City of North Vancouver, in the event of default by the Board of Debt Retirement FundTrustees of any of their duties with respect to the purchase of refunding debentures or redemption of refunding debentures. as provided in Section 24. sub-section (c) of refunding debentures, as provided in Section 24, sub-section (c) of the said Act, may then take over the said duties of the Board and meet the obligations defaulted by the said Board.

THAT Section 213d of the "Municipal Act" being Chapter 199 of the "Revised Statutes of British Columbia, 1936" as enacted by section 19 of Chapter 35 of the Statutes of 1944 is amended by inserting after "trust," in the fourth line, "for any or all lawful purposes of the Municipality or. "

THAT WHEREAS it is desirable to regulate the closing hour of

Real Estate and or insurance offices,

Therefore be it resolved that the "Shops Regulation Act" be amended by inserting after the word "on" in the fourth line of the paragraph defining the meaning of "Shop", the following words "or where the business of a real estate office and or insurance office is carried on."

. RECOMMEND that tenders be called for kalsomining the Police office and painting the wood work of same.

RECOMMEND that the Revised Estimates of School District No. 44 for The period from April 1st to December 31st 1946, as presented to the Council at its last regular meeting, be approved.
