REPORTS OF COMMITTEES
Alderman A. M. Stewart reported that a Financial Statement had been prepared by the Treasurer showing expenditures to September 30th 1946 and the estimated receipts and expenditures for the balance of the year. He pointed out that the City is in fairly good condition but this is only due to the sale of tax sale lands.

The other Committee Chairmen then commented briefly on the standing of their Departments financially, as shown by the Statements prepared by the Treasurer.

FIRE & LIGHT COMMITTEE

Alderman A. Stewart reported that he had had complaints from tax-, payers that the Standard Light at the corner of 14th Street and Lonsdale Avenue had not been replaced. He explained for the information of the Council that the pattern for this type of standard was not available but that when conditions improve the light will be replaced.

He also reported that the City had claimed damages against the driver of the car who was responsible for knocking the standard

down.

Alderman A. Stewart reported that an invitation had been received to send representatives to the Fire Chief's Convention to be held in Vancouver on October 22nd to 25th inclusive.

Alderman A. Stewart reported that the new Street Lighting Agree-( ments are in the Solicitor's hands and it is hoped that they will be completed soon.

Alderman Stewart reported that the Globes on the Lonsdale . Ornamental lights require cleaning and recommended that his Committee be given power to act in this regard.

Alderman A. Stewart reported that his Committee and the Building 1. Inspector will bring in a report on the condition of the Buildings located on Parts of Lot 9 & 10, Block 62, D.L. 548/9 on Lonsdale Avenue.

RECOMMEND that the Superintendent be authorized to return the deposits of owners who have paid same for the extension of the new Lonsdale sidewalk to their property line where it is found that it is not practical to make such extension.

Walker were appointed to meet Commissioner Sowden and the members of the City and District Town Planning Commissions with a view to coming to an understanding on the proportion of the cost to be borne by each Municipality, should the proposal be acceptable.

The Clerk reported the Council had met a delegation from the Army & Navy Emergency Shelter Committee, prior to this meeting and had discussed proposals to utilize the former Wartime Housing Staff Houses for emergency shelter.

The Finance Committee had been authorized to act with the Solicitor in this matter and it was suggested that a wire be forwarded to the Honourable C. D. Howe asking if the Government will deed these buildings and their contents over to the City for Municipal purposes for a nominal sum and the City will guarantee to turn them over to ANVA at a yearly rental equal to one-half of the normal taxes, for a term of two years, with the option to ANVA to terminate the lease at the end of the first year.

He recommended reducing the assessment on Lot 14 from \$200.00 to \$140.00 and Lot 13 from \$200.00 to \$160.00 for the year 1947.

Moved by Alderman A. M. Stewart, seconded by Alderman Gardiner that these lots be placed on reserve and Mrs. B. D. Blichfeld advised that the Council does not wish to sell them.

Letter was received from the School Board asking that the Council proceed with the preparation of a By-law to transfer a portion of Block 216 to the School Board for Gymnasium-\* Auditorium and also advising that the Agreement between the Board and the Community Centre was being prepared by Mr. Donaghy. Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that this letter be tabled until the next meeting of the Council. Carried.

The Secretary of the Town Planning Commission reported that the Commission recommended that the proposed subdivision of Lots 25 and 26, Block 22, D. L. 273 as requested by Ronald M. Howard be not granted as the subdivision would serve no practical purpose. Moved by Alderman Gostick, seconded by Alderman Gardiner that the recommendations of the Town Planning Commission be accepted and Mr. Howard advised accordingly. Carried.

The Commission reported that they had considered the application of D. M. Powelson to re-zone Lots 20 and 21, Block 30, D.L. 548/9 and recommended that no further re-zoning be allowed until the new Master Plan is received.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the application to re-zone as set out above be considered at a hearing for that purpose to be held on October 21st at 7:50 p.m. Carried.

The Town Planning Commission reported that they had studied the Zoning By-laws of six leading Canadian Cities and it was their recommendation that no change be made in the local Zoning By-law where it concerns the erection of Churches in residential areas.

Ordered received and filed.

Report was received from the Superintendent of Works in reply to

the complaint of S. Pattenden of 1745 McKay Avenue.

The Superintendent pointed out that the drainage problem complained of had been created by the former owner of the adjoining property who had excavated the Boulevard to a depth of over two feet below the level of the highway.

Moved by Alderman Gostick, seconded by Alderman A. M. Stewart that Mrs. S. Pattendon be advised in accordance with the report of the Superintendent and that under the circumstances the City cannot remedy the situation. Carried. cannot remedy the situation.

The Clerk was ordered to send a copy of the telegram which would be prepared by the Finance Committee for submission to Mr. Howe, to War Assets Corporation, Vancouver for their information and guidance.

Alderman A. M. Stewart reported that a Hearing had been held on the suspension of C. G. Limpret and T. H. Heape of the Social Assistance Office.

After discussion the following motions were offered.

Stewart, seconded by Alderman Walker and resolved that the Mayor and Clerk of the City of North \* Vancouver be and they are hereby authorized to execute and sign a certificate detailing the following persons permanent employees of the Corporation under the Unemployment Insurance Act, 1940:

Moved by Alderman A. M. Stewart, seconded by Alderman Gardiner that the following employees be included in the Superannuation Scheme from November 1st 1946:

and that Herbert John Milman be included in the Employees Life Insurance Scheme. Carried

The Clerk submitted a report of the Medical Health Officer on water samples taken during the past month, showing that out of twenty standard samples taken from Lynn Creek - five showed the presence of Coli-aerogenes bacteria; and of forty standard samples tested from Mosquito Creek - four contained Coli-aerogenes bacteria.

Ordered received and filed.

Moved by Alderman A. M. Stewart, seconded by Alderman A. Stewart that the Provincial Government be asked to cancel the appointment of T. H. Heape as a Commissioner for taking Affidavits and to appoint W. N. Keeling in his place. Carried

The Clerk reported that Order-in-Council No. 2424 had been resceived approving the "City of North Vancouver Bus Franchise Bylaw, 1946."

The Clerk reported that By-law No. 1761 was now registered in \*the County Court at Vancouver.
Ordered received and filed.

Moved by Alderman A. M. Stewart, seconded by Alderman Walker that the "City of North Vancouver Tax Lands Sale By-law 1946, No. 31" be reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Carried unanimously.

Corporate Seal. Carried unanimously.

Whereupon the By-law was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1767.

Moved by Alderman Gardiner, seconded by Alderman Walker that "The City of North Vancouver Tax Lands Sale By-law 1946, No. 32" be introduced and read a first time. Carried Whereupon the By-law was read a first time.

Moved by Alderman Gardiner, seconded by Alderman A. M.Stewart that "The City of North Vancouver Tax Lands Sale By-law 1946, No. 32" be read a second time. Carried Whereupon the By-law was read a second time.

Moved by Alderman A. M. Stewart, seconded by Alderman Walker that the Committee proceedings be dispensed with and that "The City of North Vancouver Tax Lands Sale By-law 1946, No. 32" be read a third time. Carried.

Whereupon the By-law was read a third time.

Moved by Alderman A. M. Stewart, seconded by Alderman Gardiner that "The City of North Vancouver Tax Lands Sale By-law 1946, No. 32" be passed by the Council, subject to reconsideration. Carried.

Voting for the By-law: Aldermen Gostick, Gardiner, A. Stewart, A. M.Stewart, Walker and Mayor Loutet.

A delegation was present in connection with the proposed changes to the "Gasoline Stations Early Closing By-law."

Moved by Alderman A.M. Stewart, seconded by Alderman Gostick that this delegation be heard. Carried

Whereupon Mr. Kennard addressed the Council on behalf of the Local Operators. After discussion, the Solicitor was instructed to draft the proposed By-law with the provision that one station in the City must remain open after 6.00 p.m. on every night, and that this service be given on a rotation basis by the Operators and on the understanding that each station will provide a notice to patrons where service can be obtained after the hour of 10;00 p.m.

UNFINISHED BUSINESS

Moved by Alderman Gardiner, seconded by Alderman A.M.Stewart that the l¢ Students Tickets be abolished from the schedule of the present Ferry Tariff as provided for in the Amending By-law passed by the Council on September 16th 1946; and that the By-law be now forwarded to the Public Utilities Commission for their approval. Carried Alderman A. Stewart voted against the motion.

Alderman A. M. Stewart reported that a letter had been printed by the "North Shore Review" in the issue of October 18th, making a personal attack on Alderman A. Stewart and he felt that he should draw the attention of the Council to the fact that the criticism was apparently intended for him and that the writer of the letter had confused the two Aldermen.

Moved by Alderman Gardiner, seconded by Alderman Walker that the City Clerk write to the North Shore Review and ask that they apologize for printing the above letter referred to, as same was purely a personal attack and was of a nature that should not have been printed by the paper in any case. Carried.

The Clerk submitted a letter from the Central Housing & Mortgage Housing Corporation, advising that they are willing to contribute \$4,000.00 as a grant to the City of North Vancouver towards the total cost of the purchase of the former Staff Houses from War \*Assets Corporation, and advising that upon receipt of proper estimates of the cost of conversion for emergency housing, that they meet with representatives of the Council and discuss this matter further.

Moved by Alderman A. M. Stewart, seconded by Alderman Walker that the Clerk be instructed to advise Central Housing & Mortgage Housing Corporation to forward their cheque for \$4,000.00 to be applied by the City in payment on account of the purchase by the City from War Assets Corporation of the Staff Houses and the Commissary located on Lots 1 to 10, Block 142, D.L. 274, for the sum of \$9,044.76. Carried

Moved by Alderman A. M. Stewart, seconded by Alderman Walker that upon receipt of the grant from the Central Housing & Mortgage Corporation of \$4,000.00, the Clerk draw the attention of War Assets Corporation to their offer of September 27th 1946, and advise that the City is now prepared to purchase the Staff Houses at their price of \$9,044.76 on condition that the present lease held by Wartime Housing Limited be surrendered to the City and that Wartime Housing Limited pay the proportion of the rent for the current year up to the date of the surrender of the lease, and also pay the water rates in full up to the date of surrender. Carried

Moved by Alderman Gardiner, seconded by Alderman Walker that the Finance Committee be authorized to work with the Solicitor on the 5 terms of the proposed lease with ANVA in connection with the latters proposal to sublet the Staff Houses for the emergency shelter of Veterans. Carried

Correspondence with the North Vancouver School District in connection with the transfer of land to the School Board for Gymnasium-Auditorium site, was left on the table pending receipt of information requested by the Council.

The Council agreed to discuss the new street lighting contracts with the B. C. Electric Railway Company Limited at the Committee meeting to be held on the 28th of this month.

Moved by Alderman A. M. Stewart, seconded by Alderman Walker that the notice of termination of the agreement between the City and the Metropolitan Health Committee, dated June 19th 1946, be extended a further four months so that same will expire on April 20th 1947, provided that the City's expenditure for Health Unit costs will remain on the same basis as during the year 1946, having in mind

that the Goldenberg Report on Provincial and Municipal Relations should be available at that time and the whole matter of Health costs can be reviewed.

Moved by Alderman Walker, seconded by Alderman Gardiner that this Council adjourn.
Whereupon the Council adjourned at I1;00 p.m.
