#### FERRY COMMITTEE

Alderman Gardiner reported that the suggestions regarding Ferry operations submitted by a Special Committee of the North Vancouver Board of Trade, had been carefully considered by the Ferry Committee and the following recommendations were unanimously adopted:-

- 1. That it is considered imperative that Ferry service be retained.
- 2. That automobiles be continued to be transported as long as equipment having available auto space is continued to be used.
- 3. That No. 3 Ferry be disposed of as soon as practicable:
- 4. That No. 4 Ferry be remodelled to provide additional passenger space.
- 5. That No. 5 Ferry remain unchanged as is.
- 6. That the elimination of automobile traffic in order to reduce loading time is considered unnecessary, inasmuch as the reduction in loading time so represented would not make possible a fifteen minute service with present equipment.
- 7. That a fifteen-minute Ferry service would not coincide with a ten and twenty minute bus service.
- 8. That replacement of present Ferries with smaller vessels is not possible at the present time but that it should be kept in mind that, when circumstances permit, the inauguration of a ten-minute service is most desirable:
- 9. That the matter of the obtaining of a more suitable location as a south terminal is worthy of investigation and should be looked into when circumstances permit.
- 10. That at the North Vancouver terminal ticket turnstiles should be transferred from the East to the West side of Lonsdale Avenue at the earliest opportunity in order that Ferries may be passenger loaded more expediently by their movement on the West side and, of course, unloaded via the East side where now stands the present turnstiles.
- 11. That every effort be extended to reduce expenditures before giving consideration to a possible increase in rates to increase revenue.
- RECOMMEND that the Superintendent of Works be authorized to lay out v temporary bus terminal facilities in the vicinity of Esplanade and Lonsdale Avenue.

RECOMMEND that the Executives of the Board of Trade and Ratepayers Association be invited to discuss with the City Council the proposal to establish a proper bus terminal at the foot of Lonsdale Avenue and further that the Superintendent of Works arrange with the B. C. E. R. Company to have a representative present when the Clerk has arranged the joint meeting.

Alderman Gardiner reported that the Ferry Superintendent had returned to his duties today.

Moved by Alderman Gardiner, seconded by Alderman Copping that the report of the Ferry Committee on the Board of Trade recommendations relative to the Ferry operations be received and the matter given further consideration, and that the remaining recommendations and reports be adopted. Carried

#### BOARD OF WORKS

Alderman Copping reported that the new Tractor-Bulldozer and Grader had been ordered by the Superintendent of Works but that the new power shovel would not be available until next year.

#### FIRE & LIGHT COMMITTEE

Alderman A. Stewart reported that he had interviewed B. C. E. R. Officials, Burrard Dry Dock Officials and other interested parties in regard to the decoration of Lonsdale Avenue for the Christmas Season. A scheme of lighting had been worked out with the Burrard Shipyard offering the equipment necessary for the Lower end of Lonsdale Avenue and it was proposed that the lighting on each fixture installed would be supplied by the merchant whose store was adjacent thereto.

He therefore recommended as follows:That the City contribute one-third of the cost of the scheme of lighting proposed provided that the City's share does not exceed \$100.00 and that the equipment will become the property of the Corporation.

RECOMMEND that the Burrard Dry Dock and the various organizations responsible, be thanked for their generous assistance in this matter.
