"This being the first meeting in 1947, I wish to welcome to the Council Alderman Frank Goldsworthy and am sure he will find the rest of the Council anxious to co-operate with him in the best interests of the City. During the past two years the time of the Council has been largely taken up with matters which could not be delayed and other matters of importance to the City have, of necessity, been temporarily sidetracked. It is my hope that during this year it will be possible to actively deal with these matters and that some results will be achieved.

As some of you are aware, the City's financial position has for some time been seriously affected by the unsatisfactory relationship between the City and the Federal and Provincial Governments. Foremost among these matters is the question of the taxation of Crown lands. This matter has been the subject of negotiation with Ottawa during the past two years but so far the Dominion Government has not admitted any liability under the agreement which was signed in 1928. The City has carried out its part of the agreement and every effort should be made to induce the Dominion Government to carry out its part.

The Wartime Housing agreements while by no means favourable to the City, should now be reviewed and in view of the fact that the war has been over for 16 months and as the Government has taken no action to declare a date for the termination of the various agreements, I propose to lay before you a plan for dealing with this matter and ask you to give it due consideration.

The Cameron Report which was expected to relieve the Municipality financially, has proved a disappointment and the amendments to the School Act have not tended to improve the relations between the School Board and the Council. In conjunction with other Municipalities it is to be hoped we can place education on a more satisfactory basis and while the Goldenberg Report may not deal specifically with education it will, no doubt, have a bearing on the problem. It is expected that the Goldenberg Report will be presented at the next Session of the Legislature and that more care will be given in implementing this report than was the case with the Cameron Report.

While much has been done to improve our water system, there is still a great deal to do and I hope that many citizens now receiving service on temporary lines will, this year, be connected to permanent mains.

When the transportation system is in full working order, other problems will arise and, in the meantime, it is to be hoped that in co-operation with other public bodies we will be able to arrive at a satisfactory solution of the connection with our ferry system without unduly straining our financial resources.

without unduly straining our financial resources. I trust that in carrying out the development essential to the City, by exploring other means of revenue we may be able to maintain the present tax rate, as, in my opinion, a higher tax rate would

retard our development both residentially and industrially. I feel sure that, as in the past two years, I will receive the wholehearted co-operation of the Council.

If, however, in the opinion of the Returning Officer there is a reasonable doubt as to the accuracy of the result of any poll thus obtained, or if a written request is received from any candidate or candidates or agent of any candidate for a recount prior to the declaration by the Returning Officer of the results of the poll, the Returning Officer shall proceed to count the ballots in the manner set out in Sections 72-83 following."
